Dear Ms. Crockford:

The Berkshire District Attorney replies to your request for certain records, dated February 8, 2017, as follows:

- 1 Any written description of the procedure for approval of the issuance by the District Attorney for Berkshire County of an administrative subpoena pursuant to the provisions of § 17B;
  - A sample request form, which must be submitted to the District Attorney from any police department seeking permission to use an administrative subpoena, is included for your information.
- 2 A sample of the form of a § 17B administrative subpoena used by the Office of the District Attorney for Berkshire County;
  - Two sample forms are attached.
- 3 Records showing the number of § 17B administrative subpoenas issued by the District Attorney for Berkshire County in each year for the years 2014, 2015, and 2016;
  - Please see the attached list of administrative subpoenas issued for the years 2014 through 2016.
