

### WHAT THE ADMIN IS SAYING | Senate Democrats Have a Constitutional Duty to Secure the Border

WH IGA: President Trump Sends a Letter on Border Security to Congress

State and Local Leaders,

As a follow-up to the email below, we wanted to share with you a **recent letter sent by President Donald Trump to Members of Congress on the need to secure the border**. The President also attached a presentation that Secretary of Homeland Security Kirstjen Nielsen was planning to deliver during a meeting with Congressional leadership in the White House Situation Room earlier this week. The letter and accompanying presentation has been sent to Congressional Leadership and will be hand delivered to all Members of Congress throughout the day.

As the presentation makes clear, current funding levels, resources, and authorities are woefully inadequate to meet the scope of the problem. We are no longer in a status quo situation at the Southern Border but in a crisis situation. Status quo funding is not enough.

- In fiscal year (FY) 2018, 17,000 adults at the border with existing criminal records were arrested by Customs and Border Protection (CBP) and border agents.
- In FY2017 and FY2018, ICE officers arrested approximately 235,000 aliens on various criminal charges or convictions within the interior of the United States—including roughly 100,000 for assault, 30,000 for sex crimes, and 4,000 for homicides.
- We are now averaging 60,000 illegal and inadmissible aliens a month on our Southern Border.
- Last month alone, more than 20,000 minors were smuggled into the United States.
- The immigration court backlog is nearly 800,000 cases.
- There has been a 2,000 percent increase in asylum claims over the last five years, with the largest growth coming from Central America—while around 9 in 10 claims from Central American migrants are ultimately rejected by the immigration courts, the applicant has long since been released into the interior of the United States.

YUMA, Arizona—Right along the southwest border, sheriff's departments are left picking up the pieces in the wake of cross-border crime. It then spreads beyond the border.

Consequently, sheriffs need a bigger seat at the table during border security discussions, said ex-Marine and Yuma County Sheriff Leon Wilmot.

"We all too often see interviews in Washington [with] mayors and governors but, no offence, they are not the ones that are down here on the border," Wilmot said in an interview at his office on May 25. "They are not the ones that are investigating the crimes. They are not the ones out here when it's 120 degrees, processing a crime scene where 14 people were left to die in the desert."

Wilmot has witnessed it all in his 30-plus years with the sheriff's department. He knows a vulture will peck a human body down to nothing but bone, because he has seen it. He knows bandits follow the smugglers over the border and rape the women before running back to Mexico, because he is left with the victims. He knows the cartels will commit any crime to get drugs and humans across the border.

Yuma County is 5,522 square miles—larger than the state of Connecticut—and it shares 126 miles of border with Mexico. California and its Imperial Sand Dunes are just a mirage away on the western border beyond the Colorado River.

The Yuma Border Patrol Sector used to be the worst in the country for illegal crossings, until it became a poster-child for the effectiveness of a border fence.

In 2005, before the fence, more than 2,700 vehicles crossed the Colorado River and open deserts, loaded with illegal immigrants and drugs, according to Border Patrol numbers.

Apprehensions steadily increased to more than 138,000 in fiscal 2005.

"Yuma battled entrenched smuggling groups for control of the border," said Border Patrol in a video. "Mass incursions often left agents outnumbered 50 to 1. Agents were assaulted with rocks and weapons daily."

Following the Secure Fence Act of 2006, Yuma tripled manpower and added mobile surveillance, as well as fencing and vehicle barriers.

Yuma went from having 5.2 miles of fencing to 63 miles, and subsequently saw an almost 95 percent decrease in border apprehensions by 2009, when Border Patrol made about 7,000 arrests.

# TRANSCRIPT | President Trump Addresses the Nation on the Crisis at the Border

My fellow Americans: Tonight, I am speaking to you because there is a growing humanitarian and security crisis at our Southern Border.

Every day, Customs and Border Patrol agents encounter thousands of illegal immigrants trying to enter our country. We are out of space to hold them, and we have no way to promptly return them back home to their country.

America proudly welcomes millions of lawful immigrants who enrich our society and contribute to our nation. But all Americans are hurt by uncontrolled, illegal migration. It strains public resources and drives down jobs and wages. Among those hardest hit are African Americans and Hispanic Americans.

Our Southern Border is a pipeline for vast quantities of illegal drugs — including meth, heroin, cocaine and fentanyl. Every week, 300 of our citizens are killed by heroin alone — 90 percent of which floods across from our Southern Border. More Americans will die from drugs this year than were killed in the entire Vietnam War.

In the last two years, ICE officers made 266,000 arrests of aliens with criminal records – including those charged or convicted of 100,000 assaults, 30,000 sex crimes and 4,000 violent killings. Over the years, thousands of Americans have been brutally killed by those who illegally entered our country, and thousands more lives will be lost if we don't act right now.

This is a humanitarian crisis – a crisis of the heart and a crisis of the soul.

Last month, 20,000 migrant children were illegally brought into the United States — a dramatic increase. These children are used as human pawns by vicious coyotes and ruthless gangs. 1 in 3 women are sexually assaulted on the dangerous trek up through Mexico. Women and children are the biggest victims by far of our broken system.

This is the tragic reality of illegal immigration on our Southern Border. This is the cycle of human suffering I am determined to end.

My Administration has presented Congress with a detailed proposal to secure the border and stop the criminal gangs, drug smugglers and human traffickers, it's a tremendous problem. Our proposal was developed by law enforcement professionals and border agents at the Department of Homeland Security. These are the resources they have requested to properly perform their mission and keep America safe – in fact, safer than ever before.

The proposal from Homeland Security includes cutting-edge technology for detecting drugs, weapons, illegal contraband, and many other things. We have requested more agents, immigration judges and bed space to process the sharp rise in unlawful migration fueled by our very strong economy. Our plan also contains an urgent request for humanitarian assistance and medical support.

Furthermore, we have asked Congress to close border security loopholes so that illegal immigrant children can be safely and humanely returned back home.

Finally, as part of an overall approach to border security, law enforcement professionals have requested \$5.7 billion dollars for a physical barrier.

At the request of Democrats, it will be a steel barrier rather than a concrete wall. This barrier is absolutely critical to border security. It's also what our professionals at the border want and need. This is just commonsense.

The Border Wall would very quickly pay for itself. The cost of illegal drugs exceeds \$500 billion dollars a year — vastly more than the \$5.7 billion dollars we have requested from Congress. The wall will also be paid for, indirectly, by the great new trade deal we have made with Mexico.

Senator Chuck Schumer – who you will be hearing from later tonight – has repeatedly supported a physical barrier in the past, along with many other Democrats. They changed their mind only after I was elected President.

Democrats in Congress have refused to acknowledge the crisis. And they have refused to provide our brave border agents with the tools they desperately need to protect our families and our nation.

The federal government remains shutdown for one reason and one reason only: Because Democrats will not fund border security.

My Administration is doing everything in our power to help those impacted by the situation. But the only solution is for Democrats to pass a spending bill that defends our borders and re-opens the government.

This situation could be solved in a 45 minute meeting. I have invited Congressional Leadership to the White House tomorrow to get this done. Hopefully, we can all rise above partisan politics in order to support national security.

Some have suggested a barrier is immoral. Then why do wealthy politicians build walls, fences and gates around their homes? They don't build walls because they hate the people on the outside, but because they love the people on the inside. The only thing that is immoral is the politicians to do nothing and continue to allow more innocent people to be so horribly victimized.

America's heart broke the day after Christmas when a young police officer in California was savagely murdered in cold-blood by an illegal alien who just came across the border. The life of an American hero was stolen by someone who had no right to be in our country.

Day after day, precious lives are cut short by those who have violated our borders.

In California, an Air Force Veteran was raped, murdered and beaten to death with a hammer by an illegal alien with a long criminal history. In Georgia, an illegal alien was recently charged with murder for killing, beheading, and dismembering his neighbor. In Maryland, MS-13 gang members who arrived in the United States as unaccompanied minors were arrested and charged last year after viciously stabbing and beating a 16-year-old girl.

Over the last several years, I've met with dozens of families whose loved ones were stolen by illegal immigration. I've held the hands of the weeping mothers and embraced the grief-stricken fathers. So sad. So terrible. I will never forget the pain in their eyes, the tremble in their voices, or the sadness gripping their souls.

How much more American blood must be shed before Congress does its job?

To those who refuse to compromise in the name of border security, I would ask: imagine if it was your child, your husband, or your wife, whose life was so cruelly shattered and totally broken?

To every Member of Congress: pass a bill that ends this crisis.

To every citizen: call Congress and tell them to finally – after all of these decades – secure our border.

This is a choice between right and wrong. Justice and Injustice. This is about whether we fulfill our sacred duty to the American citizens we serve.

When I took the oath of office, I swore to protect our country and its people. And that is what I will always do, so help me God.

# PRESIDENT DONALD J. TRUMP'S PLAN TO REOPEN THE GOVERNMENT AND FUND BORDER SECURITY

"To every member of Congress: Pass a bill that ends this crisis. To every citizen: Call Congress and tell them to finally, after all of these decades, secure our border. This is a choice between right and wrong, justice and injustice. This is about whether we fulfill our sacred duty to the American citizens we serve." – President Donald J. Trump

PRESIDENTIAL LEADERSHIP: President Donald J. Trump is showing strong leadership by working with Congress to find a solution to reopen our government and secure the border.

- The President is solving the decades old problem of border security.
- The negotiation team tasked by President Trump has been working with Republicans and Democrats to find a compromise to reopen the government while providing border security.

• The President is bringing together the best ideas from both sides to come up with solution to a complex problem.

# RESPONSIBLE GOVERNMENT FUNDING: The bipartisan and common sense legislation proposed by President Trump will reopen our government and secure the border.

- \$5.7 billion to fund a steel barrier system, including embedded investments in technology and roads, on our southern border in the priority areas cited by Border Patrol.
  - This is in addition to the more than 115 miles of barriers already built, replaced, or contracted under President Trump.
- \$805 million for technology, canines, and personnel to help stop the flow of illegal drugs, weapons and other contraband. This includes:
  - o \$675 million for drug detection inspection technology to help secure our ports of entry.
  - \$130 million for canine units, training, personnel and portable scanners to help deter and detect smuggled narcotics, weapons, and other dangerous materials.

# BIPARTISAN SOLUTION: As part of President Trump's willingness to compromise to reopen the government, he is proposing to grant provisional status to current DACA and Temporary Protected Status (TPS) recipients.

- Provisional status will be granted for three years for current DACA recipients, covering 700,000 illegal immigrants brought here by their parents at a young age.
  - o This status will give them access to work permits, social security numbers, and protection from deportation.
- Provisional status will be granted to certain current TPS recipients for three years, providing 300,000 immigrants whose protected status is facing expiration more certainty as Congress works on a larger immigration deal.

# IMMEDIATE CRISIS: President Trump's proposal would solve the immediate security and humanitarian crisis at our southern border, but would not solve all of our immigration challenges.

- America faces an immediate humanitarian crisis from our unsecured border.
  - According to a 2017 Doctors Without Borders Report, more than 30 percent of women are sexually assaulted on the trek to the border.
  - On average, the United States Border Patrol refers approximately 50 individuals to a hospital or medical provider, including children who cross the border in need of medical attention.
  - o The number of families and unaccompanied children crossing the border illegally has grown dramatically in recent months. This past December, Border Patrol apprehended 32,284 families and unaccompanied children. Just six months prior, Border Patrol apprehended only 13,164 families and unaccompanied children.
- The country still faces serious immigration issues that need a permanent solution, including interior enforcement, asylum reform, worksite verification, the 11 million people living in the country unlawfully, and moving toward a merit-based immigration system.
  - Once the government is open and the immediate crisis is addressed, President Trump will hold weekly bipartisan meetings to reform our immigration system.

- Rep. Eric Swalwell (D-CA): "Increase Border Patrol agents. Increase enforcement of overstay of visas. Increase use of technology and yes fencing where there are vulnerabilities."
- Rep. Cheri Bustos (D-IL): "If we have a partial wall. If we have fencing. If we have technology used to keep our border safe. All of that is fine."
- Rep. Steny Hoyer (D-MD) When asked about a wall working responds "Obviously they work".
- Rep. Debbie Dingell (D-MI): "You would be surprised at the amount of money people are willing to put into border security and it would contain many things. ... If there are places that some kind of barrier should be part of it, then that's part of it."
- Asked if the Democratic House leadership is willing to spend \$5.7 billion on a wall or border security, House Majority Whip Jim Clyburn (D-SC): "We may be, so as long as there's supporting evidence that that's what's required."

## <u>Fact Sheet – President Donald J. Trump's Fight Against the Opioid Epidemic Continues to Help Americans</u> Around the Country

"Together, we will defeat this epidemic – it's a true epidemic – as one people, one family, and one magnificent nation under God." – President Donald J. Trump

### MAKING PROGRESS: On the one-year anniversary of the launch of President Donald J. Trump's initiative to tackle the driving forces of the Opioid Crisis, progress has been made.

- One year ago, President Trump unveiled his Initiative to Stop Opioid Abuse, a first-of-its-kind effort to draw out the factors fueling the opioid crisis and make real change.
- Since the launch of the initiative, the Administration has unveiled numerous programs designed to reduce opioid demand, cut off the flow of illicit drugs, and save lives.
  - The programs span the breadth of the Federal Government from health-directed initiatives in the Department of Health and Human Services (HHS) to law enforcement activities in the Department of Justice (DOJ).
- The President has secured \$6 billion in new funding over two years to fight opioid abuse, and the Administration has awarded \$1.5 billion for State Opioid Response grants.
  - This money funds vital programs throughout the Federal Government, as well as directly supporting State and local initiatives to address the opioid crisis in our communities.
  - The DOJ has awarded more than \$400 million to support treatment, prevention, and domestic law enforcement efforts.

- In total, President Trump and his Administration are committed to addressing the opioid epidemic and solving this public health crisis in partnership with State, local, and tribal leaders.
- The President has provided local teams of experts to assist States and providers with training and education on how best to address the crisis in their State.

### CUTTING OFF THE SUPPLY: In the past year, the Administration has taken action to target the international and domestic suppliers of illicit opioids.

- Key to President Trump's opioid initiative was his crack-down on the illicit suppliers of dangerous drugs like fentanyl, both in the United States and abroad.
- Thanks to the President's efforts to improve border security, officials have prevented thousands of pounds of fentanyl from entering America.
  - o In FY 2018, at the southern border alone, between ports of entry, Customs and Border Protection seized enough fentanyl to kill nearly 90 million Americans.
- In America, the DOJ shut down the country's biggest Darknet distributor of drugs, seizing more than 4.8 kilograms of drugs and enough fentanyl to kill 105,000 Americans.
  - The DOJ has also worked diligently to increase indictments against dealers of illicit drugs and has targeted seizures in areas hit hardest by the opioid crisis.
  - The President supports strengthening criminal penalties and invoking mandatory minimums for drug dealers knowingly distributing lethal amounts of opioids.
- According to the Drug Enforcement Administration (DEA), from 2017 to the present, more than 16,000 kilograms of heroin and nearly 5,000 kilograms of fentanyl have been seized in the United States.
- President Trump's leadership on DEA's National Take Back Days shattered records, recovering nearly 3.7 million pounds of unused prescription drugs.
- More illicit shipments of drugs are being stopped through the mail than before.
  - o From FY 2016 to FY 2018, postal inspectors achieved a 1000 percent increase in international parcel seizures and a 750 percent increase in domestic parcel seizures related to synthetic opioids.
- The DOJ is tackling the prescription opioid crisis by expanding fraud and abuse detection while also holding manufacturers accountable.

### REDUCING DEMAND: Along with cutting down on the supply of opioids, the Administration has made great strides in reducing demand in the United States.

- The Administration is helping to educate millions of Americans about the dangers of opioid misuse and is working to curb over-prescription.
- Thanks to the Trump Administration's partnership with the Truth Initiative and Ad Council, 58 percent of young American and 1.4 billion viewers have seen ads highlighting the dangers of opioids.
  - o In the President's first year in office, 107,000 fewer adolescents started misusing prescription painkillers and 68 percent fewer Americans over the age of 26 began using heroin than in the previous year.
- New efforts within the Trump Administration are resulting in a decline of opioid prescribing nationwide.
- The Administration issued the highest number of Drug-Free Communities Support Program grants in the program's 20-year history, providing more than \$90 million to community coalitions to strengthen the infrastructure among local partners to prevent youth substance use.

## HELPING AMERICANS RECOVER: President Trump and his Administration are helping individuals afflicted by drug addiction throughout the country.

- President Trump knows that without assisting Americans struggling with addiction, efforts to cut off supply and demand will be in vain.
- To that end, the Trump Administration has taken steps to expand the supply of lifesaving naloxone to first responders nationwide.
- The Trump Administration is working to expand access to evidenced-based addiction treatments in every State and to our Nation's veterans.
- Reforms to the criminal justice system are being made in order to identify and treat offenders already struggling with addiction.

- The Administration increased funding for drug courts by 53 percent.
- The Administration is providing State and local leaders with data to help coordinate and optimize efforts to combat addiction and overdose.
- The Department of Housing and Urban Development has utilized its homeless service programs to treat substance abuse disorders throughout the Nation.
- Additionally, President Trump's workforce development efforts are expanding job retraining and apprenticeships to those recovering from drug addiction.

- Last year, President Trump launched his Initiative to Stop Opioid Abuse and Reduce Drug Supply and Demand, a first-of-its-kind effort to draw out the factors fueling the opioid crisis and to make real change.

  - o These programs range from health initiatives led by the Department of Health and Human Services (HHS) to increased law enforcement through the Department of Justice (DOJ).

- The Administration is working with State, tribal, and local partners to address the opioid crisis in our communities, including awarding \$1.5 billion annually in State Opioid Response grants.
  - The Administration provided teams of experts to assist States and providers with training and education on how best to address the crisis in their area.
- HHS grant funding to combat this crisis went up 4-fold from FY 2016 to FY 2018, and will increase again this fiscal year.
- DOJ has awarded more than \$400 million over 2017 and 2018 to support treatment, prevention, and domestic law enforcement efforts.
- The Trump Administration awarded the highest number of Drug-Free Communities Support Program grants in a single year in the program's two-decade history.
  - These grants provided more than \$90 million to community coalitions to help prevent substance use among youth.
- President Trump's efforts are producing results and he is committed to continuing the fight until we end this crisis.
- The rising overdose death toll through September 2018, the latest month for which data is available, has flattened compared to November 2017, when we saw the peak 12-month mortality.
- Nationwide, there has been an estimated 5 percent decrease in reported deaths since the same 12-month period a year ago.
- Drug overdose deaths were down in the most recent 12-month reporting period compared to a year ago by an estimated 13 percent in New Hampshire, 20 percent in West Virginia, 11 percent in Iowa, 21 percent in Pennsylvania, and 22 percent in Ohio.

# STOPPING DEADLY DRUG SUPPLIES: A vital part of President Trump's efforts to stop opioid abuse is stopping the illicit drug supplies that are flooding into our communities.

- The Trump Administration is working to cut off the deadly drug supplies that have helped fuel this devastating crisis.
  - o More than 16,000 kilograms of heroin and nearly 5,000 kilograms of fentanyl have been seized in the United States since the beginning of 2017, according to the Drug Enforcement Administration (DEA).
- The Administration has stepped up funding and enhanced efforts to stop deadly drug supplies from flowing into our communities.

- President Trump is following through on his commitment to crack down on the suppliers of deadly, illicit drugs like fentanyl—both in the United States and abroad.
  - o President Trump secured a commitment from President Xi that China would take measures to prevent trafficking of Chinese fentanyl.
  - Last fall, President Trump called on other nations to join our efforts to stop the flood of illicit drugs into our communities, and more than 130 countries have joined us already.
- President Trump's efforts to secure our border are helping to stop deadly drugs from being brought into our country.
  - The Department of Homeland Security seized almost 5,000 pounds of fentanyl in FY 2018—totaling 1.2 billion lethal doses, or enough to kill every American four times.
  - Customs and Border Protection (CBP) seizures of fentanyl alone are up 265 percent over the last two full fiscal years.
- In 2018, President Trump established the first new High Intensity Drug Trafficking Areas program in 17 years to combat emerging threats in Alaska.
  - As a result, the program now has a footprint in all 50 States.
- The Administration has cracked down on the distribution of deadly drugs over the internet, including shutting down the country's biggest Darknet distributor of drugs.
  - o During that operation, DOJ seized enough fentanyl to kill 105,000 Americans.
- DOJ has worked to bring drug dealers to justice by increasing indictments and has targeted seizures in areas hit hardest by the opioid crisis.
  - The President has also made clear that he supports strengthening criminal penalties for drug dealers knowingly distributing lethal amounts of opioids.
- Under President Trump, the DEA's National Take Back Days have shattered records, recovering nearly 3.7 million pounds of unused prescription drugs.
- Thanks to the President's efforts, more shipments of illicit drugs are being stopped through the mail before they can reach our communities.
  - o CBP has stopped over six times more packages containing fentanyl thanks to the STOP Act included in last year's opioid legislation.
  - Postal inspectors saw a 1,000 percent increase in international seizures and a 750 percent increase in domestic seizures related to synthetic opioids from FY 2016 to FY 2018.
- The Administration is also tackling the prescription opioid crisis by expanding fraud and abuse detection and holding drug manufacturers accountable.

# PREVENTING OPIOID ABUSE: The Trump Administration has made vital progress on reducing drug demand in an effort to address the root causes of this crisis.

- President Trump's Administration has aimed to reduce demand by educating Americans about the dangers of opioid misuse and working to curb over-prescription.
- The Administration partnered with the Truth Initiative and Ad Council to educate youth about opioid misuse though an ad campaign that led to 1.4 billion total views.
  - o 58 percent of young adults between the ages of 18 and 24 are aware of the ads.
- In the President's first year in office, 107,000 fewer adolescents started misusing prescription painkillers.
  - o Further, 68 percent fewer Americans over the age of 26 began using heroin than in the previous year.
- The Trump Administration's efforts have helped generate a decline in opioid prescribing nationwide.
  - o In the first two years of the Administration, we saw a 34 percent decrease in the total amount of opioids prescribed.

- The Department of Veterans Affairs' (VA) Opioid Safety Initiative has reduced the number of veterans on opioids by 43,395 in President Trump's first two years in office—an 11 percent decline.
- The Administration is tackling opioid distribution fraud, including taking down \$3.3 billion in opioid connected fraud from 60 prescribers across seven States in Appalachia.
- The Department of Labor (DOL) is reducing prescription opioid use among injured Federal workers.
  - o These efforts led to a 29 percent decrease in certain opioid prescriptions during President Trump's first 14 months, relative to the same time period in 2015-2016.

# SUPPORTING PATIENTS THROUGH RECOVERY: The Trump Administration is committed to supporting our neighbors, friends, and family members who are struggling with addiction.

- In order to truly defeat this crisis, it is vital that we support Americans struggling with addiction. Otherwise, efforts to cut off supply and demand will be in vain.
- President Trump's Administration is working to ensure Americans facing addiction receive the care that they need.
  - 255,000 more Americans received substance use treatment in 2017 compared to 2016.
  - More young Americans aged 18 to 25 received outpatient treatment in 2017 than in 2016.
  - o 64 percent more patients received medication-assisted treatment at community health centers funded by the Health Resources and Services Administration in 2017.
  - The Centers for Medicare and Medicaid Services has helped 18 States expand access to inpatient and residential addiction treatment programs for low-income patients.
- The Administration has taken steps to expand the supply of lifesaving naloxone to first responders nationwide.
  - There has been a 484 percent increase in naloxone dispensed monthly since President Trump took office.
  - Naloxone prescriptions jumped 27 percent immediately following the Surgeon General's advisory recommending that more Americans carry it.
  - The VA alone dispensed 121,448 naloxone prescriptions, used to help 321 veterans during an overdose.
- The Trump Administration is working to expand access to evidence-based addiction treatments in every State and to our Nation's veterans.
- Criminal justice reforms are being enacted to identify and treat offenders struggling with addiction.
  - The Administration has increased funding for DOJ's Drug Court program by 83 percent since 2016.
- The Administration is providing State and local leaders with data to help coordinate and optimize efforts to combat addiction and overdose.
- The Department of Housing and Urban Development funds supportive housing for individuals with substance abuse disorders through its homeless service programs.
- President Trump's workforce development efforts are expanding job retraining and apprenticeships to those recovering from drug addiction.
  - DOL awarded over \$53 million to 12 States and the Cherokee Nation to help people affected by opioid addiction rejoin the workforce.





**2019 Starts off with a Bang in the First Quarter with Strong Economic Performance** (article <u>here</u>)



As discussed in the 2019 *Economic Report of the President*, the Council of Economic Advisers demonstrated that the strong economic performance in 2017 and 2018 was not merely a continuation of trends already under way during the preceding post-recession expansion, but rather constituted a distinct break from trend and positive surprise relative to expectations. We see in today's advance estimate of real GDP growth in the first quarter of 2019 that the economy continues to outperform expectations.




As shown in the figure below, in their final longer-term forecasts before the November 2016 election, the Congressional Budget Office and the Federal Open Market Committee on average projected four-quarter real GDP growth in 2017, 2018, and 2019 of 2.2, 2.0, and 1.7 percent, respectively. In actuality, real GDP grew 2.5 percent in 2017, 3.0 percent in 2018, and in the first quarter of 2019 grew at an annualized rate of 3.2 percent.

Moreover, we consider the 2019: Q1 advance estimate likely underestimates the current pace of economic growth in the United States for two reasons. First, as shown in the following table, in recent years estimates of real GDP growth in the first quarter of a calendar year have on average been below growth during the subsequent three quarters. Indeed, over the past 25 years, the Q1 estimate has, on average, been 0.9 percentage point lower than the average of Q2, Q3, and Q4 estimates. This suggests there may be some lingering seasonality in the official estimates of first-quarter real GDP growth.



Second, the Bureau of Economic Analysis (BEA) now estimates that the partial government shutdown in 2019: Q1 lowered the overall growth rate of real GDP by 0.3 percentage point at an annual rate. In their technical note, the BEA states that "the full effects of the partial federal government shutdown on the first quarter estimates cannot be quantified because they are embedded in the regular source data that underlie the estimates and cannot be separately identified." In the absence of residual seasonality and the government shutdown, real GDP growth in the first quarter of this year might have been up to 1.2 percentage points higher, implying an annualized growth rates of 4.4 percent.



# What The Admin Is Saying | Larry Kudlow and Kevin Hassett Tout the Booming American Economy

NEC Director Larry Kudlow and CEA Chair Kevin Hassett Discuss the First Quarter GDP Numbers and the Tremendous State of the Economy.

#### ON TODAY'S FIRST QUARTER GDP NUMBERS

Today's report on GDP growth in the first quarter was a blow-out, showing President Trump's policies are working.

NATIONAL ECONOMIC COUNCIL DIRECTOR LARRY KUDLOW: "It is a blow-out number and I'll just say that President Trump's policies are rebuilding the economy. And actually, the prosperity cycle we're in is gaining momentum."

COUNCIL OF ECONOMIC ADVISERS CHAIRMAN KEVIN HASSETT: "I think you add that all together, this is really blockbuster news."

The fact that we saw such strong growth in the first quarter – which is typically the worst quarter of the year – signals that the economy is going to keep growing.

KUDLOW: "The first quarter's supposed to be the worst quarter of the year. So, it comes in at 3.2%. It tells me, among other things, that the prosperity cycle we have entered into is continuing, it's strong, it's got legs, and it's got momentum and, frankly, it's going to go on for quite some time."

We are experiencing sustainable growth in line with the Trump administration's expectations.

HASSETT: "Our forecast for this year, wait for it, was 3.2% for the year. So, if you ask me, geez, given the news of the first quarter are you going to revise your forecast, I have a hard time thinking of why, except for, maybe, we'll revise it up."

Exports are growing and recent data shows companies are investing in their operations.

KUDLOW: "In today's report, net exports was a driver of the 3.2% GDP that's terrific. That's a Trump policy that continues."

KUDLOW: "[In my view, Companies] are shifting now to a huge capital expansion. And that means better technology, better plants and equipment, modernization, it also means better training and reskilling – as my colleague Ivanka Trump, would say – reskilling of the work force and the work force is coming out the woodwork back in, so they will be counted. And the unemployment rate will probably continue to fall. This is an ideal situation."

#### ON THE STATE OF THE ECONOMY

### The economy is firing on all cylinders thanks to the President's policies.

KUDLOW: "Look, supply-side tax cuts, deregulation, opening the energy sector, pro-growth trade reform, that's improving the supply-side, the production and investment side of the economy."

KUDLOW: "One stat that's interesting from the durable goods [orders] yesterday. From December through March core capital goods spending – core cap-ex, as it's called – is actually growing at a 10% annual rate. That's a terrific pick-up. At the same time, we saw a huge retail sales number in April."

### President Trump is rebuilding our economy and renewing optimism across America

KUDLOW: "The President is rebuilding incentives, he's rebuilding confidence, he's rebuilding optimism. Individuals have money, wages are rising with the job numbers that have been terrific. That's very important."

### The President has ended the war on business and the war on success.

KUDLOW: "Now, is this going to last. Alright? I believe it will. As long as these policies are in place. As long as the incentive model, you know – the President ended the war on business, he's ended the war on success, he's basically saying you should keep more of what you earn, he's basically saying to small businesses we're going to cut the paperwork back and make it easier for you to start a business and prosper. I might add, new business formation is really rising sharply. That's a great number."

KUDLOW: "This is the new Trump economy. Some people don't like that or they don't agree with that. I respect the differences, but I'll tell you, it seems to be working."

## The inflation rate continues to slip lower and lower while economic growth is actually improving.

KUDLOW: "Let me also add, the inflation rate continues to slip lower, and lower."

KUDLOW: "It's not growth that we worry about. As inflation is coming down, growth is actually improving or at least sustaining a 3% growth rate, so I basically like that story."

KUDLOW: "I know old-style analysis says fast growth means higher inflation, you know I've never bought into that. I still do not buy into that. What you're getting now is more goods, and more production, and more output -3.2% in Q1 – that, actually, is chasing less money, so, therefore, the inflation rate is coming off. I think that's very significant."

#### UNITED STATES-MEXICO-CANADA TRADE FACT SHEET

### Strengthening North American Trade in Agriculture

The United States, Mexico and Canada have reached an agreement to benefit American farmers, ranchers, and agribusinesses. While agriculture has generally performed well under NAFTA, important improvements in the agreement will enable food and agriculture to trade more fairly, and to expand exports of American agricultural products.

### Key Achievement: Expanded Market Access for American Food and Agricultural Products.

America's dairy farmers will have new export opportunities to sell dairy products into Canada. Canada will provide new access for United States products including fluid milk, cream, butter, skim milk powder, cheese, and other dairy products. It will also eliminate its tariffs on whey and margarine. For poultry, Canada will provide new access for United States chicken and eggs and increase its access for turkey. Under a modernized agreement, all other tariffs on agricultural products traded between the United States and Mexico will remain at zero.

#### Key Achievement: Canada's Milk Classes 6 and 7 to Be Eliminated

The top priority for America's dairy industry in this negotiation has been for Canada to eliminate its program that allows low priced dairy ingredients to undersell United States dairy sales in Canada and in third country markets. As a result of the negotiation, Canada will eliminate what is known as its milk classes 6 and 7. In addition, Canada will apply export charges to its exports of skim milk powder, milk protein concentrates and infant formula at volumes over agreed threshold, which will allow United States producers to expand sales overseas.

### Key Achievement: Setting Unprecedented Standards for Agricultural Biotechnology

For the first time, the agreement specifically addresses agricultural biotechnology to support 21st century innovations in agriculture. The text covers all biotechnologies, including new technologies such as gene editing, whereas the Trans-Pacific Partnership text covered only traditional rDNA technology. Specifically, the United States, Mexico, and Canada have agreed to provisions to enhance information exchange and cooperation on agricultural biotechnology trade-related matters.

# Key Achievements: Significant Commitments to Reduce Trade Distorting Policies, Improve Transparency, and Ensure Non-Discriminatory Treatment for Agricultural Product Standards

Building on NAFTA, the United States, Mexico, and Canada agreed to work together in other fora on agriculture matters, improve transparency and consultations on matters affecting trade among the countries.

The United States, Mexico, and Canada agreed to several provisions to reduce the use of trade distorting policies, including:

- To not use export subsidies or World Trade Organization (WTO) special agricultural safeguards for products exported to each other's market.
- Improved commitments to increase transparency and consultation regarding the use of export restrictions for food security purposes.
- If supporting producers, to consider using domestic support measures that have minimal or no trade distorting or production effects and ensure transparency of domestic support and supply management programs.

Canada and the United States also agreed to strong rules to ensure tariff-rate quotas are administered fairly and transparently to ensure the ability of traders to fully use them.

### **Key Achievement: Fair Treatment for Quality Requirements for Wheat and other Agricultural Products**

Canada has agreed to grade imports of United States wheat in a manner no less favorable than it accords Canadian wheat, and to not require a country of origin statement on its quality grade or inspection certificate. Canada and the United States also agreed to discuss issues related to seed regulatory systems.

To facilitate the marketing of food and agricultural products, Mexico and the United States agreed that grading standards and services will be non-discriminatory for all agricultural goods and will establish a dialogue to discuss grading and quality trade related matters.

Key Achievement: Enhanced Rules for Science-Based Sanitary and Phytosanitary Measures

In the Sanitary and Phytosanitary (SPS) Measures chapter, the United States, Mexico, and Canada have agreed to strengthen disciplines for science-based SPS measures, while ensuring Parties maintain their sovereign right to protect human, animal, and plant life or health. Provisions include increasing transparency on the development and implementation of SPS measures; advancing science-based decision making; improving processes for certification, regionalization and equivalency determinations; conducting systems-based audits; improving transparency for import checks; and working together to enhance compatibility of measures. The new agreement would establish a new mechanism for technical consultations to resolve issues between the Parties.

### Key Achievement: New Disciplines on Geographic Indications

For the first time in NAFTA, the United States and Mexico have agreed to geographical indication standards that: enhance transparency for opposition and cancellation proceedings for geographical indications (GIs); establish a mechanism to consult on GIs pursuant to international agreements; and allow for additional factors that may be taken into account in determining whether a term is a common name instead of a GI.

#### Key Achievement: Market Access for Certain Cheese Names

In addition, for the first time in a United States trade agreement, Mexico and the United States agreed to not restrict market access in Mexico for U.S. cheeses labeled with certain names.

### Key Achievement: Prohibiting Barriers for Alcohol Beverages

The United States, Mexico, and Canada agreed to non-discrimination and transparency commitments regarding sale and distribution, and labeling and certification provisions to avoid technical barriers to trade in wine and distilled spirits. They agreed to continue recognition of Bourbon Whiskey, Tennessee Whiskey, Tequila, Mezcal, and Canadian Whisky as distinctive products.

#### Key Achievement: New Protections for Proprietary Food Formulas

The United States, Mexico, and Canada agreed on the Annex on Proprietary Food Formulas, which requires each Party to protect the confidentiality of proprietary formulas for food products in the same manner for domestic and imported products. It also limits such information requirements to what is necessary to achieve legitimate objectives.

### President Trump Secures A Modern, Rebalanced Trade Agreement with Canada and Mexico

"[USMCA] is a great deal for all three countries, solves the many deficiencies and mistakes in NAFTA, greatly opens markets to our farmers and manufacturers, reduces trade barriers to the U.S. and will bring all three Great Nations together in competition with the rest of the world." – President Donald J. Trump

• DELIVERING AS PROMISED: President Donald J. Trump is keeping his promise to deliver a modern and rebalanced trade deal with Mexico and Canada.

- President Trump has negotiated a new United States-Mexico-Canada Agreement (USMCA), which will benefit American workers and businesses where North American Free Trade Agreement (NAFTA) has failed.
