Dear Attorney Rótolo:

On November 3, 2010, I received a letter from you dated November 1, 2010 requesting copies of certain records alleged to be maintained by the Dennis-Yarmouth Regional School District. Your letter requested copies of documents regarding surveillance cameras installed in Dennis-Yarmouth schools and police access to those cameras. While the School District has complied with your request, given the number of documents requested and the amount of staff time necessary to compile said documents, we are unable to waive the fees associated with this service. Therefore, in accordance with 950 CMR 32.06 (2), we are charging you \$23.25 for your record request.

Please find attached the following documents:
