Item #6 of your request asks for "Any documents showing the location of cameras inside any and all of the schools in Lexington." Pursuant to the Massachusetts Public Records Law, G. L. c. 4, § 7 (26)(n)., documents related to this part of your request are exempt from public disclosure as the release of this information is "likely to jeopardize public safety."

While we are waiving the costs incurred in providing you with the enclosed documents, we anticipate the retrieval, segregation, output, and duplication of items specified in Item #2 may require a substantial amount of time and resources. If you are still interested in our estimating the cost of producing the documents requested in Item #2, please write and let me know.
