Re: Public Records Request dated March 18, 2019

Dear Ms. Rousseau:

I write in reference to the ACLU of Massachusetts ("ACLUM") request for public records dated March 18, 2019 (the "Request").

As you are aware, the ACLUM's Request to the Bristol County Sheriff's Office (the "BCSO") sought production of nine categories of records. ACLUM has received two productions from the BCSO related to its Request, the first dated May 29, 2019 and the second dated June 11, 2019. The BCSO's responses and productions to the Request contain serious deficiencies and call into question the reasonableness and efficacy of the BCSO's methods for searching, reviewing and producing documents related to the Request. The deficiencies that ACLUM has identified to date are outlined below. This letter is not intended to be an exhaustive list of the deficiencies in the BCSO's responses and productions and ACLUM reserves all rights.

I. Request No. 2

Request No. 2 calls for "[a]ll tweets and replies, and all direct messages to or from, the Twitter account @Sheriff_Hodgson." The Request attached a screenshot containing additional account information to assist in identifying the Twitter account that is the subject of this request. In our May 24, 2019 letter, we noted that, after the Request was submitted, BCSO modified the identifies of two of the Twitter accounts referenced in the Request (including modifying the @Sheriff_Hodgson account to @SheriffHodgson). We also noted that the legal obligations to produce the requested records concerning these accounts persists and that ACLUM expects BCSO to produce all direct messages from these accounts.

The BCSO has refused to produce any of the requested records related to the @Sheriff_Hodgson Twitter account (now @SheriffHodgson, and hereinafter referred to as such). In the BCSO's May 29, 2019 response, it stated: "Twitter account @Sheriff_Hodgson is not a Sheriff's Office Twitter account; thus, no records exist that are responsive to this request."

The BCSO's May 29 response provides no explanation for its position that the Twitter account at issue is "not a Sheriff's Office Twitter account," and no further explanation for its refusal to produce documents responsive to Request No. 2. The BCSO's apparent position that the Twitter account at issue is not subject to a public records request is unsupported by the facts and the law.

First, posts and direct messages sent and received by the @SheriffHodgson account are well within the definition of "public records." M.G.L. ch. 4 §7 ("Public records' shall mean all books, papers . . . or other documentary materials or data, regardless of physical form or characteristic, made or received by any officer or employee of any agency, executive office, department, board, commission, bureau, division or authority of the commonwealth, or of any political subdivision thereof, or of any authority established by the general court to serve a public purpose, or any person, corporation, association, partnership" (emphasis added)). As such, this information is subject to a public records request under Massachusetts law. M.G.L. ch. 66 § 10.

Second, the BCSO's assertion that the account is "not a Sheriff's Office Twitter account" is completely at odds with the account's use. The account is explicitly linked to the BCSO in numerous ways and is regularly used for purportedly official BCSO business. For example:

- The biographic information provided for @SheriffHodgson explicitly links the account to the BCSO, including identifying the user by his official title and linked to the BCSO's own Twitter account. See Exhibit 1.
- The account is frequently used to release and/or announce purportedly official letters and statements on official BCSO letterhead. *See* Exhibit 2.
- The account is used to announce and/or share BCSO initiatives, decisions, press statements, and other purportedly official work. *See* Exhibit 3.

Sheriff Hodgson cannot simultaneously use this Twitter account is his official capacity and for purportedly official BCSO business, and also withhold its contents from the public. Accordingly, please produce all direct messages responsive to Request No. 2 no later than September 10 2019.

II. Request Nos. 8 and 9

Requests Nos. 8 and 9 concern "any request, decision, or recommendation by BCSO to participate in, or not participate in, any pilot program for the delivery of medication-assisted treatment for opioid use disorder at county correctional facilities, including under Section 98 of Chapter 208 of the Acts of 2018." These requests call for "all records" of and "all records concerning the formulation or preparation for" any such request, decision, or recommendation.

The BCSO's May 29 response stated that no records exist that are responsive to these requests. However, based on publicly available information, the ACLUM has sufficient reason to believe that documents responsive to this request do, in fact, exist.

At the BCSO's annual 287(g) steering committee meeting held on April 10, 2019, Sheriff Hodgson publicly announced that the BCSO will not implement the pilot program established by Section 98 of Chapter 208 of the 2018 Acts, and will, instead, continue its current practices for treating inmates for opioid disorder. During this meeting, Sheriff Hodgson made a number of statements that suggest he and/or the BCSO have records concerning this decision. For example, he stated:

- "The sheriffs all met not too long ago a few months back and collectively we decided, for those that were going to decide to use medically-assisted treatment, that there would be a sampling of four or five sheriffs who were going to do it to see how it goes. Medically-assisted treatment is very controversial with regards to the types of medication that have to be given. For example, when somebody is on a medically-assisted treatment program, there are certain medications where it takes ten minutes per person to have that medication dissolve in their mouth, and they have to watched by a person on our staff until it is done."
- "We have probably the most difficult county when it comes to detoxing people for drug use."
- "I am not going to institute a program that's going to have people ... come to jail who want to get off drugs, be exposed to more drugs. Because if you can't go to jail to get off drugs, I don't know where you're going to go to get off drugs."
- "We aren't going to institute programs that we don't know [are] working yet, as are a number of other Sheriffs, until we know it works."

Accordingly, no later than September 10, 2019, please: (1) confirm whether records responsive to Requests 8 and 9 exist and produce any such records; (2) confirm whether any documents responsive to Requests 8 and 9 are being withheld on the basis of any assertion of privilege; and (3) provide a description of what, if any, searches the BCSO undertook to

identify records responsive to these requests, including the sources and custodians BCSO searched and any date ranges and/or search terms that it applied.

III. <u>Deficiencies in BCSO's Document Productions</u>

Apart from the issues identified above, we have identified numerous deficiencies in BCSO's first and second productions. Both productions demonstrate that BCSO failed to produce records responsive to the Request, including variations of certain email chains and attachments to emails. Below are only a few examples of incomplete email chains and/or emails with missing attachments. Because BCSO's productions do not include any Batesnumbering or other unique-identifiers, included below are our best descriptions of these examples.

- First production dated May 29, 2019: "Miscellaneous communications between Sheriff or staff and White House or Secret Service," PDF pages 1, 7 and 98.
- Second Production dated June 11, 2019:

Sheriff Hodgson's statement on criminal protesters

The rule of law is the framework that protects our individual liberties, our democracy and our nation. It outlines the rights and wrongs so our neighborhoods, communities, counties and country can be safe places to live, work and raise a family.

The rule of law matters in Bristol County, Massachusetts, where criminal protesters were recently sentenced to time behind bars for violating our laws.

I thought about this today while watching the news coverage of the protesters who blocked the entrance to the Immigration and Customs Enforcement headquarters in Washington on Tuesday, preventing hard-working Americans from entering their workplaces. I hope the 11 protesters who were arrested are prosecuted to the fullest extent of the law.

There is a lawful way to protest and express you First Amendment rights. Last month, for example, more than 50 anti-ICE protesters gathered near the main entrance of the Bristol County House of Correction. They held signs and sang songs. They didn't trespass or cause any disturbances. No arrests were made, no incidents occurred and everyone went home after the demonstration.

It was a far cry from other protest demonstrations over the past year that resulted in jail sentences. In August, two individuals used tripod structures to hoist themselves 30 feet off the ground and block the main entrance to our facility, while two others used bike locks and tires full of cement to block our secondary entrance. They put many lives in danger by blocking emergency vehicles' access to our jail, and tied up police officers, fire fighters and other first responders who had to use the Jaws of Life and a jackhammer to free the protesters. In April, two more individuals were arrested for disrupting a public meeting about our partnership with ICE. They were yelling and screaming and being extremely disruptive to the panelists and the meeting attendees.

One of these protesters served a 10-day sentence in jail for their actions, while another just started a similar sentence. Another received a suspended sentence, probation and a hefty restitution fine. Others are still going through the legal process.

A 51-year-old man from Honduras clutched a 6-month-old baby as he waded across the Rio Grande into the United

A single father hoping for a better life for his young baby? A man hoping to find steady employment to support his child? Not quite.

The man paid 2,000 lempira (the equivalent of \$80 U.S) to buy — yes buy — the baby and a fake birth certificate from its mother. When border security officers in McAllen, Texas, told the man they would be testing their DNA, he came clean and fessed up to the scheme.

Customs and Border Patrol, Immigration and Customs Enforcement and the Department of Homeland Security are seeing things like this all the time along the southern border, thanks to Congress' inability to pass meaningful immigration reforms and appropriate funding to secure the border.

ICE officials shared this information with Sheriffs recently. The American people have a right to know what's really going on at the border, and how America's Sheriffs and our law enforcement partners are being undermined by illegals who refuse to follow our laws and Sanctuary officials who refuse to respect our laws.

People are literally purchasing children from their parents and using them to enter the United States. And make no mistake about it, the smuggling cartels aren't doing background checks on the buyers. Imagine this: A 5- or 6-yearold sold to a violent criminal or pedophile who uses the child to enter the U.S. and then uses the cover provided by the elected official of a Sanctuary City to make it easier to abuse the child. It's very possible, and may even be happening right here in Massachusetts where Sanctuary Cities like Somerville and Boston prohibit local law enforcement from working with ICE.

There are multiple cases of child imposters being apprehended at the border: Single adult males with fake birth certificates trying to gain entry as unaccompanied minors.

The list goes on and on. ICE is even deploying teams to stop "child recycling," which is people using these kids to come across the border, then sending them back home to be used again.

Congress has intentionally failed to pass legitimate immigration reform for decades, and coupled with local elected officials creating cover for illegal aliens in Sanctuary Cities, has resulted in an unprecedented flood of illegal aliens entering the United States. The surge is simply too much to handle and many are simply being released from the border into the U.S. with a date to appear in court years down the road. More than 94% of the family units from







Our communities do not have the resources nor the budgets to handle the massive influx of immigrants we are experiencing and are expected to experience in the very near future. Our scarce resources are in danger of being rapidly depleted to the point that we will be unable to effectively care for our own citizens and our existing homeless populations, many of whom are American veterans.

We, whom you represent, request that you put politics aside and support the President of the United States in his request for the supplemental funding necessary to effectively address this crisis and provide the New Mexicans you serve with the relief we so desperately need. We implore you to protect the border and provide processes that protect immigrants and/or asylum seekers crossing into the United States properly and legally.

It is with our constituent's support and with their well-being in mind that we request you exercise your elected duty to the people whom you serve and act now in this emergency situation to overcome the politics in addressing this humanitarian crisis with no further delay. Please work with the President to give relief and security to both New Mexicans and the immigrants entering through our southern border.


