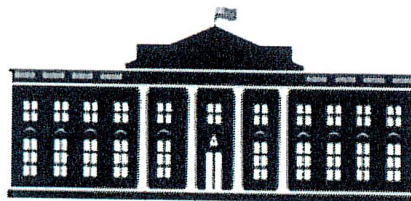

WHAT THE ADMIN IS SAYING | Senate Democrats Have a Constitutional Duty to Secure the Border

Trump Administration officials discuss the need for Congressional Democrats to put politics aside and do their solemn duty to ensure the safety of American citizens.

House Republicans did their part to help secure the border. Now Senate Democrats must do theirs.

WH STRATEGIC COMMUNICATIONS DIRECTOR MERCEDES SCHLAPP: “We had a very productive meeting with the congressional House Republicans. And the President, they worked on this deal where they said, ‘Look, we need to have that \$5 billion for border security, in addition to funding for disaster relief.’ It is a strong bill.”

WH PRESS SECRETARY SARAH SANDERS: “So the House Republicans delivered a huge victory last night for border security. We are very hopeful that the Senate will come through and help protect the American people.”

The American people want border security and the Senate has a constitutional duty to protect our communities.

SANDERS: “The Senate has a constitutional duty and a constitutional authority to actually protect our country. We can’t be a sovereign country if we don’t have borders and we don’t have protection of the American citizens and so we hope that they will step up and do their jobs today before they go home and take vacations for Christmas. This is something that is so important and we hope that they will do whatever is necessary to get the job done.”

SCHLAPP: “This is what the American people want. This is about protecting American communities and ensuring that we have enough resources for our men and women who basically risk their lives every day in dealing with illegal immigrants crossing the border.”

Our southern border is overwhelmed by a massive inflow of drugs and illegal migration.

SANDERS: “We have to put a stop to the massive inflow of drugs, human trafficking and terrorists coming across our border. We need to know who is coming, in why they are coming and what they are going to do when they get here. We have to have an orderly process.”

Walls work – they are vital to ensuring the safety and security of Americans.

SECRETARY OF HOMELAND SECURITY KIRSTJEN NIELSEN: “Walls work. We know they do. We have seen it in San Diego, we’ve seen it Yuma, everywhere we have that physical infrastructure we see illegal immigration drop by 95%. .. We’ve got to get the wall done.”

SANDERS: “We need a wall and border security in order to have that we have to protect the people of this country and the President is going to stand firm and make sure that that happens one way or another.”

“It is a sad day in America that the Mexican government is doing more to protect the American people than Senate Democrats.”

SANDERS: “One thing that I think has been missed and didn’t get a lot of coverage yesterday was what we have worked out, what this administration has been able to do in conjunction with the Mexican government and the massive and monumental moment that took place yesterday where catch and release is ending.”

SANDERS: “And it is a sad day in America that the Mexican government is doing more to protect the American people than Senate Democrats. I hope that will not be the case by the end of the day and they will work with us and work with the president and Senate Republicans to get this done and let everybody go home and let us start building the wall and let us start protecting our border.”

President Trump is standing true to his promise to enhance border security.

SANDERS: “The President is not going to back down on this and he is going to stand firm because it’s so important and it’s such a vital part of our democracy to make sure that we are protecting our borders and protecting the people of the country.”

NIELSEN: “The President will continue to advocate for what the men and women of the Border Patrol say they need and this is what it is: its physical infrastructure along with the technology and personnel that go to it.”

HIGHLIGHTS | President Trump on the Need for Border Security Funding

President Trump is grateful that House Republicans united together in order to pass border security funding.

PRESIDENT TRUMP: “It was a tremendous evening for the Republicans, to be honest with you, because the level of spirit, the level happiness. A lot of people came out and said they have never seen – one man in particular, he’s been there for 20 years, he says ‘I’ve never seen the spirit or enthusiasm like this.’”

PRESIDENT TRUMP: “They came from all parts of the country. A couple came from other parts outside, so I say all parts of the world, in order to vote. And they voted. And it was an incredible vote.”

PRESIDENT TRUMP: “I want to thank House Republicans, because what they did was rather incredible.”

Senate Republicans also want border security and safety for our country.

PRESIDENT TRUMP: “I think I can speak for [Senate Republicans] very strongly, when I say that they want to see something happen on border security. They want safety for our country.”

Congress must act to fix the crisis at our border.

PRESIDENT TRUMP: “Drugs are pouring in and we have done an incredible job considering we have no barrier. But drugs are pouring into our country.”

PRESIDENT TRUMP: “Human trafficking is at the all-time worst in history ... The human trafficking problem is a problem that has gone on through the ages, but it’s never been worse because of the internet. All over the world. This isn’t just the United States, this is all over the world. So we need border security”

PRESIDENT TRUMP: "This is a very big issue. It's an issue of crime. It's an issue of safety. It's an issue of ... dollars."

PRESIDENT TRUMP: "We spend \$285 billion a year on illegal immigration. We have to finally do it. The wall will pay for itself on a monthly basis. I mean, literally every month it pays for itself. So we are talking about small amounts of money."

Despite the tiny fraction of the Federal budget requested for border security, Congressional Democrats are willing to shut down the government over partisan politics.

PRESIDENT TRUMP: "So it's a tiny fraction [of money]. But, unfortunately, [Congressional Democrats have] devoted their lives to making sure it doesn't happen. And that wasn't for what should happen. That was for political reasons. ... so it's really a Democrat shutdown."

PRESIDENT TRUMP: "It's totally up to the Democrats as to whether or not we have a shut down. It's possible that we will have a shut down. I would say the chances are probably very good, because I don't think Democrats care so much maybe about this issue."

PRESIDENT TRUMP: "This is our only chance that we will ever have, in our opinion, because of the world and the way it breaks out, to get great border security."

A national emergency in plain sight

Five days ago, President Donald J. Trump signed a Homeland Security appropriations bill that earned a number of important legislative victories for our country. At the same time, he used his legal authority as President to take executive action to address the immediate national security and humanitarian crisis at our Southern Border.

“It’s very simple: We want to stop drugs from coming into our country. We want to stop criminals and gangs from coming into our country,” the President said Friday from the White House Rose Garden. “We don’t control our own border.”

The crisis is real. Pretending it doesn’t exist is an insult to those who face its consequences every day. “January saw a surprising surge of 22,000 more apprehensions of illegal immigrants at southwest border crossings over January 2018, prompting a key predictor to suggest that border officers will make over 600,000

apprehensions this year,” Paul Bedard reports for the [Washington Examiner](#).

Politicians and the media should listen to our experts in law enforcement. The lack of physical infrastructure at our southern border is continuously being exploited for illegal purposes, U.S. Customs and Border Protection officials explain. To their point, take a look at a string of recent arrests along our border:

- [103 illegal aliens](#) from Central America detained Monday morning
- [Two sex offenders](#) arrested in separate weekend incidents
- [Multiple criminal aliens](#) arrested over the holiday weekend, including some with warrants and convictions for sexual assault, kidnapping, and murder
- [A convicted rapist](#) caught in El Centro, California
- [A previously deported MS-13 gang member](#) recently apprehended
- [Nearly \\$1 million of drugs](#) seized in the Rio Grande Valley

Behind the numbers are real stories of suffering. When America can't vet who crosses its border, our citizens, including legal immigrants, suffer. On Friday, one such “angel mom”—a legal immigrant whose only son was killed by someone here illegally—told CNN's Jim Acosta something that every American should agree with: “We need to protect this country.”

Her son's death was preventable. Our leaders had the power to stop it, and they chose not to. For years, Washington put political convenience over real national security.

If that isn't a crisis, nothing is.

The world's worst immigration laws

Time and again, President Donald J. Trump has warned that America's immigration and border security systems are outdated and at risk of being overwhelmed. Today, nearly 3 years after he first issued a call to action, that is exactly what is happening.

The problem begins with a broken patchwork of immigration loopholes and opportunistic court rulings, which President Trump has asked Congress to help him fix for more than a year. The situation only grows worse by the day. "A liberal activist judge in San Francisco ruled the United States and Mexico can't work together to address asylum issues at the border," Press Secretary Sarah Sanders [wrote this morning](#).

Congress chose not to act. So President Trump alone must address the consequences.

In March, U.S. Customs and Border Protection agents were involved in more than 100,000 border

enforcement actions—the highest number for any single month in more than a decade. For context, that figure is up more than *500 percent* since March 2017.

Behind these numbers is a new story and a new problem. In the past, a large majority of illegal immigrants were single adult males from Mexico who could be returned across the border quickly. Today, the surge comes from “asylum seekers” from Central America, many of whom are coached by smugglers on how to exploit America’s generous system for refugees.

The predictable result is a meltdown at our border, as law enforcement resources and personnel are diverted from core responsibilities and stretched far beyond capacity.

On Friday, President Trump got a firsthand look at the emergency on our border. There’s no way to prepare for “the amount of people, ‘family units,’ and children, and now organized caravans that are coming across this border today,” Gloria Chavez, Chief Patrol Agent of the El Centro Sector, told him. “Our agents are being stretched in so many different directions.”

All of this can be fixed by Congress committing to immigration principles that a large majority of Americans agree with. But for now, it is up to President Trump to enforce our laws and close the gaps in our porous border.

“It’s sad that Mexico is now doing more to secure our border than Democrats,” Press Secretary Sanders writes. “President Trump will do whatever it takes to keep Americans safe.”

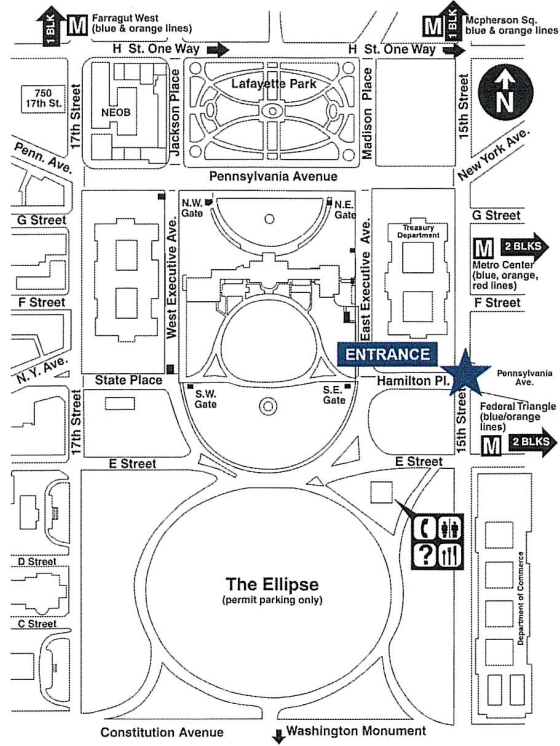

What You Need To Know | By the Numbers: The Urgent Border Crisis Facing Our Nation

As Democrats in Congress refuse to provide funding to secure the border, we continue to face an urgent crisis of illegal immigration.

- Over 60,000 migrants have arrived at our border each of the last three months.
- Of those 60,000, around 85% illegally crossed our border and 15% presented themselves at a port of entry without documents.

Mike McDaniel, Director, Houston High Intensity Drug Trafficking Areas (HIDTA)

Michael McDaniel began his law enforcement career in 1983 as a police officer with the City of Houston Police Department after graduating from Baylor University in Waco, Texas. In 1987, Mr. McDaniel accepted a position as a special agent with the Drug Enforcement Administration (DEA), and was assigned to the Houston DEA office for 12 years, working domestic and international drug investigations. In 1997, he was promoted to the Special Operations Division (SOD) in Lorton, Virginia, as a Staff Coordinator in the Southwest Border Section. In 2000, Mr. McDaniel was transferred to a Group Supervisor position in the San Antonio, Texas, DEA office where he supervised the DEA San Antonio High Intensity Drug Trafficking Areas (HIDTA) enforcement group. In 2007, he was promoted to Resident Agent in Charge of the Las Cruces, New Mexico, Resident office where he was responsible for DEA enforcement operations in Southern New Mexico. In December 2008, he was promoted to Assistant Special Agent in Charge of the Houston DEA office. In September 2011, Mr. McDaniel retired from DEA after 24 years of service to accept a position as the Houston HIDTA Director.

Mr. McDaniel has served as the chair of the HIDTA Directors' Committee since October 2016.



Steve Marshall, Attorney General of Alabama

During his time as District Attorney, Marshall established a reputation for being tough on crime. He founded the Marshall County Major Crimes Unit, the Marshall County Computer Forensics Lab, and the Marshall County Crystal Meth Task Force. He was selected to serve on the Board of Directors for the National District Attorneys Association. He also served as chairman of the Alabama Criminal Justice Information System and as a member of the Alabama Sentencing Commission.

As Attorney General, Marshall has embraced his role as the state's chief law-enforcement officer and is using his platform to make Alabama a safer place to live. On January 24, 2018, Marshall launched his Initiative on Violent Crime—reinvigorating partnerships with federal, state, and local law-enforcement agencies to combat violent crime in Alabama. The mission, Marshall declared, is to “help cities reclaim their streets, restore the rule of law, and, ultimately, see their communities revived.” To date, the Initiative has resulted in the arrests of nearly 300 violent offenders. He also successfully advocated for the passage of the Fair Justice Act—a significant pro-victims law that streamlines the appeals process for death-row inmates.

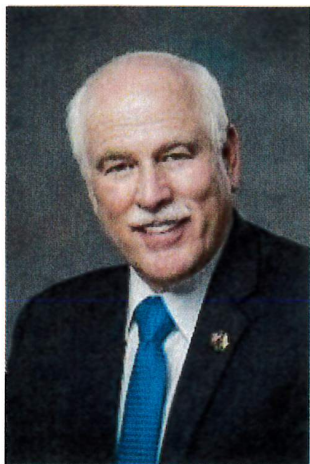
In his short time in office, Attorney General Marshall has established himself as a national leader on a variety of policy matters, including the opioid crisis. Marshall has served as a cochairman of the Alabama Opioid Overdose and Addiction Council, whose work has been lauded as a “best practice” for states. He has lent his expertise on the issue to addiction-prevention and recovery advocates and law-enforcement groups throughout the state and country. Marshall has also been recognized for his work on matters related to illegal immigration. He was invited to speak at the White House on the challenges currently facing Immigrations and Customs Enforcement (ICE) and Customs and Border Protection (CBP). He also testified before Congress about how the counting of illegal immigrants in the U.S. Census will negatively affect Alabama's representation in Congress and in the electoral college. In November 2018, Marshall was elected to the Executive Committee of the Republican Attorneys General Association.



Sheriff Tony Childress, Livingston County, IL

Tony Childress is the Sheriff of Livingston County, Illinois. He was first appointed in 2013 and has worked for the Sheriff's Department for more than 25 years. Childress is a strong proponent for strong enforcement of immigration laws, the border wall, the e-verify program, and funding for more ICE agents. Childress states his community is particularly impacted by drug and sex trafficking because of a stretch of Interstate 55 (connects Chicago and St. Louis) that runs

through the County. He attended the border security discussion in September 2018.



Sheriff Thomas Hodgson, Bristol County, MA

Sheriff Thomas M. Hodgson, a law enforcement and corrections professional with extensive management, marketing and business experience was appointed Sheriff of Bristol County on May 21, 1997 by Gov. William F. Weld.

In 1994, Sheriff Hodgson, a former Maryland Police Lieutenant for Special Operations, joined the staff of the Bristol County Sheriff's Office and served as Deputy Superintendent of Investigations. He also served five years as a Councilor-at-Large on the New Bedford City Council.

Upon assuming the role of High Sheriff of Bristol County, Sheriff Hodgson immediately set out to implement his goals for corrections reform, public safety and raising the standards for the Bristol County Sheriff's Office to enhance the primary mission of care and custody of inmates. He instituted structured disciplines for the inmate population and expanded the Work Release programs to include graffiti removal. He banned tobacco products for staff and inmates, removed televisions and weight-lifting equipment from cells, donating the equipment to police departments and the local Boys and Girls Club. These activities were replaced with programs affording educational opportunities, spiritual assistance and vocational aptitude.

Sheriff Hodgson has been successful in bringing together a number of Law Enforcement and Public Safety agencies through the establishment of a Law Enforcement Collaborative, consisting of Bristol County Police Chiefs, State Police and UMASS Dartmouth Police, to share intelligence and resources. The Bristol County Sheriff's Office is a member of the SouthCoast Anti-Crime Team (SCAT) utilizing the combined resources of the Sheriff's Office and Police Departments to control the proliferation of drugs and other criminal activity in the area. In support of these efforts the Sheriff has also established a Warrant Apprehension Unit, Drug Task Force, Gang Unit and has assigned staff to the federal departments of DEA, ICE, and FBI.

Sheriff Hodgson continues to remain actively involved with other sheriffs throughout the United States to call for careful and thoughtful immigration reform with an initial emphasis on securing our borders and points of entry.



Homeland Security Investigations Assistant Director Matt Allen (ICE)

Mr. Allen is the Assistant Director for Investigative Programs, Homeland Security Investigations, U.S. Immigration and Customs Enforcement, Department of Homeland Security, Washington, D.C. Mr. Allen is responsible for programmatic oversight of HSI's strategic planning, national policy implementation and the development and execution of operational initiatives.

From August 2008 until June 2016, Mr. Allen served as the Special Agent in Charge of Homeland Security Investigations in Arizona. Mr. Allen had oversight of the full spectrum of ICE investigative activities in the State of Arizona and led more than 500 personnel assigned to offices in Phoenix, Tucson, Douglas, Nogales, Sells, Casa Grande, Yuma and Flagstaff.

Mr. Allen has represented DHS and ICE in the Washington inter-agency community and, in particular, the National Security Council's Policy Coordinating Committee process. Mr. Allen has testified before both the House of Representatives and the Senate in the areas of worksite enforcement and methamphetamine smuggling.



Office of Field Operations Executive Assistant Commissioner Todd Owens (CBP)

Todd C. Owen became the Assistant Commissioner, Office of Field Operations, on February 8, 2015. Mr. Owen oversees more than 29,000 employees, including more than 24,000 CBP Officers and CBP Agriculture Specialists. He manages an annual budget of \$5.2 billion for operations at CBP's ports of entry and numerous programs that support national security and the facilitation of lawful travel and trade.

Mr. Owen was previously the Director, Field Operations (DFO), for the Los Angeles Field Office. As the DFO, he had responsibility and oversight for all CBP operations in the greater Los Angeles area, including the Los Angeles International Airport (LAX), the twin Los Angeles/Long Beach seaports, and the Las Vegas International Airport.

Prior to arriving in Los Angeles in July 2011, Mr. Owen served as the Executive Director of Cargo and Conveyance Security in Washington D.C., a position he held for six years beginning in 2005. He was responsible for all cargo security programs and policies for CBP, including the Container Security Initiative (CSI), the Customs-Trade Partnership Against Terrorism Program (C-TPAT) office, and all non-intrusive inspection technology and radiation portal monitor deployments.

Mr. Owen served as the Director of C-TPAT from January 2005 until May 2006. Before arriving in Washington, D.C., he was the Area Port Director in New Orleans, where he was directly responsible for all CBP operations throughout Louisiana. Before being selected as Area Port Director, Mr. Owen spent eight years in South Florida where he held various trade related positions within OFO and the Office of Strategic Trade.

A graduate of John Carroll University in Cleveland, Ohio, Mr. Owen began his career with the U.S. Customs Service in 1990 as an Import Specialist in Cleveland. He is a career member of the Senior Executive Service, was a senior executive fellow at Harvard University's John F. Kennedy School of Government, and holds a Master's degree in Public Administration from St. Thomas University in Miami, Florida. Mr. Owen is married and has two sons.



Chief of the Border Patrol Carla Provost (CBP)

Carla L. Provost is the Chief of the U.S. Border Patrol, located in Washington DC. Chief Provost entered on duty with the U.S. Border Patrol on January 8, 1995, as a member of Class 277. Her first assignment as a Border Patrol agent was at the Douglas Station in the Tucson Sector. She was subsequently promoted to Supervisory Border Patrol Agent in 1998, and to Field Operations Supervisor in 2001. While assigned to the Tucson Sector, Chief Provost served as an instructor for bike patrol units, firearms training, and post-academy law.

In 2006, she transferred to the Yuma Sector as Assistant Chief Patrol Agent. In 2009, she became the Patrol Agent in Charge of the Wellton Station in the Yuma Sector. While at the Yuma Sector, she directed sector budgets and human resources, and, later, oversaw all operations of the Wellton Station. In 2011, Chief Provost was appointed to the SES position of Deputy Chief Patrol Agent of the El Paso Sector.

In 2013, Chief Provost became the Chief Patrol Agent of the El Centro Sector, where she led 1,200 employees and oversaw all operations within her area of responsibility. In 2015, she became the Deputy Assistant Commissioner of the Office of Professional Responsibility, where she oversaw compliance with all CBP-wide programs and policies relating to corruption, misconduct, or mismanagement. In 2016, Ms. Provost was selected as the Deputy Chief of the U.S. Border Patrol.

Among Chief Provost's many accomplishments in her distinguished career, is her successful standup of CBP's Law Enforcement Officer Safety and Compliance Directorate, which is responsible for the development and articulation of all CBP use of force policies. In this capacity, Chief Provost led the CBP-wide implementation of its Comprehensive Use of Force Policy.

Prior to joining the U.S. Border Patrol, Chief Provost served for 2 1/2 years as a police officer with the Riley County Police Department in Manhattan, Kansas. She earned a Master of Science degree in National Resource Strategy from the Industrial College of the Armed Forces at the National Defense University in Washington, D.C., and a Bachelor of Science degree in Sociology/Criminal Justice from Kansas State University.



Director of the Department of Homeland Security Gilbert Orrantia (AZ)

Gilbert Orrantia became the Director of the Arizona Department of Homeland Security in June 2009 and currently serves Governor Doug Ducey (R, AZ). He earned his bachelor's degree from Arizona State University. Before his state service, Orrantia served in the FBI for over 25 years, where he received numerous awards and commendations, including two of the FBI's highest commendations: the Medal of Valor and the FBI Star. Orrantia has lectured at the FBI Academy on officer safety and survival, and continues to share his expertise in surviving a deadly encounter with numerous law enforcement agencies. Orrantia currently serves on the executive committee of the

National Governors Association Homeland Security Advisors Council, and also serves as the Co-Chair of the Governor's Arizona Human Trafficking Council.

President Trump Secures A Modern, Rebalanced Trade Agreement with Canada and Mexico

“[USMCA] is a great deal for all three countries, solves the many deficiencies and mistakes in NAFTA, greatly opens markets to our farmers and manufacturers, reduces trade barriers to the U.S. and will bring all three Great Nations together in competition with the rest of the world.” – President Donald J. Trump

- **DELIVERING AS PROMISED:** President Donald J. Trump is keeping his promise to deliver a modern and rebalanced trade deal with Mexico and Canada.

- President Trump has negotiated a new United States–Mexico–Canada Agreement (USMCA), which will benefit American workers and businesses where North American Free Trade Agreement (NAFTA) has failed.
