Re: Public records request pertaining to facial recognition

Andover Police Department has not contracted with Clearview AI – and to the best of my knowledge APD has not contracted with any Facial Recognition Software or Service. Investigations may use resources provided through the Commonwealth of Massachusetts Fusion Center, and at least historically the Registry of Motor Vehicles. I am not considering these to be companies that manufacture or sell facial recognition products.

All of these responses are at least related to Clearview AI, but to my knowledge extends to Facial Recognition software/services contracts.
