Hi Mr. Walsh,

Thanks for the response to my July 2018 records request related to facial recognition technology.

I have to say, I'm very confused by your response and I'm hopeful you can clarify some things for me in writing. Your September 2018 letter in response to my request states that MSA "is not, nor has been, involved in any planning, acquisition, or use of facial-recognition technology."

But you've been quoted by the press on many occasions going back nearly ten years about MSA's use of facial recognition systems, including the construction of a statewide image database for facial recognition search purposes. I am currently looking at a letter you wrote to my colleague Laura Rotolo in response to a separate records request in 2010, in which you discuss at length MSA's use of facial recognition and plans to construct this statewide database.

Are you now saying that MSA has never used facial recognition? Please advise. My assumption is that, based off your public statements and prior correspondence with my office, MSA is in fact in possession of many thousands of pages of documents responsive to my July 2018 request.
