What if the Government of Puerto Rico in an attempt to uncover and identify the massive amount of identity theft being committed against their citizens asked every State RMV/DMV to look and see if any of their residents were in their License or State ID database?

- What if Puerto Rico provided every State a copy of their license database and asked that State to compare their license holders (just over 1 million) looking for any exact matches.
- Sort of like a giant card game of "Go Fish" but all the cards are flipped over so everyone can see. No two cards or more should be the same.
- If your familiar with the "State to State" nationwide facial recognition program that is slowly being rolled out this is similar but this could be immediate.

- What your about to see is based on over 7 years of the results of this new law enforcement program called "Identifying the Impostor".
- As of Feb 2019 I have taught just over 1500 Officers, Troopers, Agents, Probation Officers, Prison Guards, etc on how to apply this program while performing their duties and there results speak for themselves.
- We have a nation wide identity theft problem that has been exploited for decades by a very large number of people and many of whom have been directly involved in the distribution and sale of heroin and cocaine throughout the U.S.
- Some parts of this program can be a little difficult to understand at first but eventually when you read a few of the police reports along with viewing several of my power points you should start to see the bigger picture.
- This is a huge opportunity for law enforcement nation wide and will allow them to identify a very large number of identity thieves who are committing all sorts of State and Federal crimes along with stealing a very large amount of State and Federal benefits.

"The SuperList" concept illustration – How to identify large amounts of fraud being committed by these Impostors. Every deck of cards has 52 cards and no deck is suppose to have two of the same cards. Every card is different!



The first card game – Puerto Rico makes a request to all the RMV/DMV's to vet their license database against the Puerto Rico license database and that all States provide Puerto Rico a list of all the matching hits.

- What we are looking for are two or more matching cards in the form of a License or State ID, two people using the same Name, Date of Birth and Social Security Number.
- This would allow the Government of Puerto Rico to reach out to their resident/citizen and inform them that their identity has been compromised or stolen.
- This would also notify the State that they have a license fraud case along with a stolen identity.
- This is that easy and the number of Impostors that will be identified will be huge.

The Second Card Game, a little more complicated Using the FBI database Triple I to identity multiple card holders using the same Name, Date of Birth and Social Security Number The Social Security number system

- When a child is born in the U.S., Mom and Dad give their child a name and on the day of birth, that date of birth is attached to the child's name. The child now has an assigned Name and Dob given to him by his parents.
- This is all recorded by the hospital on a Birth Certificate which is
 eventually sent to the Social Security Administration who then assigns a
 one of a kind social security number to the child's Name and Dob.
- The True Number Holder Very Important You now have a one of a kind, matching Name, Date of Birth and Social Security Number (SSN) belonging to a real person and documented in a Federal data base owned by the Social Security Administration.
- Mom and Dad get mailed this information in the form of a Social Security Card that them and their child will use for the rest of their lives.

What do we do with our assigned and matching Name, Dob and SSN?

- Work and pay taxes
- Apply to schools and colleges
- Apply for Driver's Licenses, State ID's, Passports
- Open lines of credit, buy cars and homes.
- Travel
- Get married
- Get divorced
- And perhaps, some of us, the True Number Holder are even committing crimes and getting arrested. What happens during the arrest, booking, finger printing and court appearance? We are identifying ourselves to the police using our assigned Name, Dob and SSN and all of that is being documented in a number of ways.

The Police Booking and subsequent finger printing. The collection of "BioMetrics"

- Technology has come a long way, during the booking process all your "Biographics", your Name, Date of Birth, SSN, height, weight, eye and hair color, address, parents names, tattoos, charges and booking photo's, etc are all entered into the Police Booking computer.
- Once this is completed, all this information is sent to the digital finger print machine located a few feet away. Now your finger printed and once that is completed the whole transaction is sent to the FBI who maintains ALL arrest records for the whole country.
- Every Police Department across the country including Puerto Rico and numerous federal agencies contribute to this data base and have so for decades.

The FBI nationwide arrest data base "Triple I" Interstate Identification Index

- When a person is arrested, booked and fingerprinted those prints are sent to the FBI for analysis.
- NO two people have the same fingerprints, everyone has different whirls, loops and arches known as print patterns on their finger tips.
- The FBI computer has the ability to recognize specific patterns based on all 10 finger tips and assigns every person who has been arrested a specific "FBI Number" based on this one of a kind finger print pattern.
- Sound familiar, like a deck of cards! We are almost there, just like a
 Social Security Number is a specific one of a kind number, a FBI
 Number is specific and exact, every person who has ever been arrested
 and printed has their own FBI Number, no two people will every have the
 same FBI Number.
- Now, attached to this specific number is all the persons criminal history, we can see where they have been arrested, when and what for along with booking photo's.

The Crime Scene

- For decades the theft of real and matching U.S. Citizens (USC) identities has been happening in very large numbers.
- The Impostor is created when a person steals the real and matching identity of a USC, that one of a kind Name, Dob and SSN and assumes that persons identity by walking into a State RMV or DMV with counterfeit or stolen documents and successfully obtains that Driver's License or State ID.
- Once that fraudulently obtained real license or State ID is handed to the Impostor with his or her picture on it, that person is now officially an Impostor.
- That License or State ID is immediate stolen US Citizenship and all the benefits that comes with it.

The "Identifying the Impostor" program and the crime scene it processes. The Impostor

- So you know what happens when the True Number Holder is arrested, booked and printed. The arrest is recorded in the FBI data base and attached to that specific FBI Number.
- Use me for an example, when I was arrested for Operating After Suspension I provided the police with my identity in the form of my Driver's License. Attached to that document is my Name, Dob and SSN and I also provided that same information at the booking window.
- I said I was Name-James Scott, Dob-1-1-80 and SSN 555-55-4321
- I was then printed and the FBI did not find a previous arrest based on my prints and they assigned me a FBI Number of "123456AB1"
- I now have a criminal record with the FBI in their Triple I data base under FBI Number 123456AB1, all my information is under that number.

The Impostor Crime Scene – Seeing double

Multiple people being arrested using the same Name, Dob and SSN

The Impostor gets arrested using the same information.



- If your playing a normal game of cards you should never see this, if you do someone is cheating!
- It's the same with the Impostor program, whenever we two people who have been arrested using the same Name, Dob and SSN always one is an Impostor.

How did this happen? The FBI data base Triple I is searchable.

- So when I was arrested, the True Number Holder and used my name James Scott, 1-1-80, 555-55-4321, I was assigned FBI Number-123456AB1
- At one point my identity is stolen, my matching Name, Dob and SSN have to be real and matching when it is presented at the RMV window. Someone obtained my identity and walked into a RMV somewhere in the U.S. and obtained a real but fraudulent license with their picture on it and subsequently got arrested. During the arrest is the Impostor going to admit to his real identity? Probably not, he is going to say he is me and go through the whole arrest and booking process pretending to be me. He will also be finger printed using my identity BUT do him and I have the same exact finger prints?
- NO! Once he is printed and the prints are sent to the FBI they will look for a match. They are not looking at the Name, Dob and SSN attached to the arrest, only the finger print pattern.
- The Impostor will be assigned his own specific FBI Number! Lets use FBI-454545DC1

Now there are two! Two Ace of Spades Triple I can be searched using Name, Dob and SSN

- Before I was arrested I was not in the FBI data base, my prints were not on file. Once I was arrested and printed I was assigned FBI-123456AB1.
 Don't forget all my biometrics are attached to that number, they are in a file cabinet that can be searched.
- If someone with Triple I access wanted to search the file cabinet using my Name, Dob and SSN they will find FBI-123456AB1, the will find "One Ace of Spades", there should only be one.
- But what if someone steals my identity, gets a Driver's License or State
 ID and also gets arrested, booked and printed using my identity?
- A search of Triple I will identify two distinct different FBI Numbers which belong to two different people however both have used the same Name, Dob and SSN during an arrest.
- "Whenever a search of Triple I using a Name, Dob and SSN shows multiple FBI Numbers using the same Name, Dob and SSN always at least one of them is an Impostor." A quote right out of the class!

So what is this "SuperList"

- Significant work and analysis has already been done between myself and the FBI in Boston and West Virginia, the Mother Ship of Triple I
- Any State or Federal Agency that has their won data base full of matching Names, Dob's and SSN's and submit their data base looking for fraud, multiple people using the same Name, Dob and SSN (Two Ace of Spades) and one of them is in your data base.
- We have identified numerous Impostors here in New England who in addition to being actively involved in the sale and distribution of heroin have also been stealing MassHealth, Section 8 and EBT, some have even voted.
- The FBI will take a copy of your data base and using your Names, Dob and SSN's will identify what we call the "Double Hits", the two or more people in the Triple I data base who have been booked and printed using the same Name, Dob and SSN.
- We can search any and all Social Security Numbers! The most prevalent and known compromised series of SSN's are from Puerto Rico, however not much attention is being given to helping these victims of identity theft.

The cost to do this is almost nothing but the payoff nation wide will be massive!



- The numbers are going to be big. This is based on over 7 years of developing, administering and teaching this program to over 1500 Officers, Troopers, Agents, Analyst, etc.
- Any State RMV or DMV can do this. Imagine all 50 plus RMV's and DMV's talking to each other and playing one giant game of cards!
- The illustration to the left is accurate, we see multiple people who have been arrested using the same Name, Dob and SSN, we even see more who have valid licenses across the country.

- This is actually a very basic presentation and only a snapshot of what the Identifying the Impostor program can do. All of our concepts and there are more are proven and are documented in over 100 police reports from departments all over Massachusetts, Rhode Island and New Hampshire.
- I know all to well that this can be a complicated topic along with many concerns of racial profiling but once you fully understand how this all works your concerns will be diminished.
- The fraud numbers are going to be large, we are seeing it now but to continue to ignore what is happening has gotten us to where we are now.

Retain 7 years.

Obtained as applicable in accordance with National Environmental Policy Act, Massachusetts Environmental Policy Act, Wetland Protection Act, US Coast Guard, Clean Water Act, Rivers and Harbors Act, Coastal Zone Management Act, Water Pollution Control Act, etc. These Permits are issued by various Regulatory Agencies for the purposes of protecting the environment by defining the manner in which various construction activities are to be performed.

C10-10: Public Hearing Transcript

Permanent.

A verbatim transcript of the design public hearing including the sign in sheet and comment letters received subsequent to the hearing. This series documents the public participation process.

C10-11: Meeting Minutes

Permanent.

This series is for the purpose of recording the discussions, recommendations and action items resulting from a project meeting. This series includes the list of meeting attendees as well as a narrative describing the meeting.

C10-12: Construction Contract Awards

Retain 7 years.

This series is for the purposes of documenting that the bid has been reviewed and if appropriate recommend award. Also to provide the necessary information to encumber funds for the Construction Contract. This series includes: Bid Tabulations, letter from consultant verifying quantities, Construction Pars No. Form, FMISD Form, Construction Contract MMARS Encumbrance Form, FIN 681 Form, and Interoffice Memorandum from the project Management Section to the Construction Section.

C10-13: Construction Proposal Book

Retain 7 years.

This series is a binding agreement between MassHighway and the Construction Contractor for the construction of the project. This series includes: Addenda, Notice to Contractors, Supplemental Specifications, M/WBE Requirements, EEO Regulations, Wage Rates, Scope of Work, Special Provisions, Detailed Sheets, Sketches, Environmental Permits, Affidavit and Itemized Bid Proposal.

C10-14: Surveying Services Contract Book

Seven years after the date of the approval of the Contract Completion Form for the consultant contract, and completion of the Audit Section Review.

This series contains standard contract form, scope, budget, standard and special provisions, exhibits and signed proposal documents. This series documents the binding agreement between MassHighway and the survey consultant for services.

C10-15: Payment Commodity Forms (PRC)

Seven years after the date of the approval of the Contract Completion Form for the consultant contract, and completion of the Audit Section Review.

This series provides the basis for bi-weekly billing for services as detailed in the contract provisions. It consists of consultant invoice and cost breakdown, direct expense back-up, and estimate of fee record.

C10-16: Daily Report of Contract Survey Party HED-121

Seven years after the date of the approval of the Contract Completion Form for the consultant contract, and completion of the Audit Section Review.

These are postcards mailed to the District Survey Office signed by all survey party members. This series provides signed documentation of personnel present on project site basis for bi-weekly billing.
