ADMINISTRATIVE SUBPOENA

Dear Sir or Madam:

Pursuant to a criminal investigation being conducted by the [REDACTED] Police Department it is requested that your company furnish to this office, all listing, billing information, biographical data, subscriber information, local and long distance telephone connection records, length of service, types of service utilized, records and source of payments for such service, [REDACTED] toll records from [REDACTED] regarding the following number(s):

You are not to disclose the existence of the request as any such disclosure could endanger the life or physical safety of persons involved; cause flight from prosecution; result in the destruction or tampering with evidence; result in the intimidation of potential witnesses; unduly delay a trial or impede the investigation being conducted and thereby interfere with the enforcement of the law.


This Administrative Subpoena is forwarded pursuant to Massachusetts General Laws chapter 271, section 17B which provides, in pertinent part, that:

*Whenever a district attorney has reasonable grounds to believe that records of a common carrier subject to the jurisdiction of the department of telecommunications and cable, or a provider of electronic communication service, or a provider of remote computer service, are relevant and material to an ongoing criminal investigation, he may demand all the records in the possession of such common carrier or provider or service relating to any such service. Such common carrier or provider or service or employee thereof shall deliver to the district attorney all the records so demanded. No such common carrier or provider or service or employee thereof shall be civilly or criminally responsible for furnishing any records or information in compliance with this demand.*

Accordingly, this Administrative subpoena is an equivalent state warrant to a warrant issued pursuant to 18 USC § 2701 et seq.
