The ALPR guidelines/policies continue to be developed and under review. EOPSS is developing two sets of guidelines/policies, one that is a model policy for police departments, should a department choose to adopt it or some version, and the second is a policy for the central repository. The central repository, which, as you may recall, will be maintained by the Criminal Justice Information Services (CJIS) Division at the Commonwealth's Public Safety Data Center, is not running at this time. I appreciate your inquiry and ask that you keep in touch in this regard. It is important for all partners to be informed.

I am also getting together something for you on the 1033 question that you had.

Hi Jane,

I am writing to follow up on the status of the ALPR policy which was discussed at the meeting at EOPSS last August. In the intervening year, a number of additional communities have purchased and deployed ALPR cameras, and substantial amounts of data about Massachusetts motorists is currently being collected. Our understanding was that EOPSS intended to create a central repository or database of this information but that statewide collection of the data had been deferred pending the establishment of a policy which would address, among other things, the extent of data that will be collected, access to that data and the length of retention. It was also our understanding that there would be an opportunity for comment before the new policy or regulations took effect.

Could you let me know where things stand?
