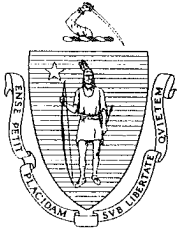

As a follow up to my previous response to your public records request concerning the Commonwealth Fusion Center, I am enclosing the following documents:


1. Commonwealth of Massachusetts State Homeland Security Strategy;
