I.A – Portfolio – Overall Investment Justification

Discuss at a broad level the principle hazards, risk and capability gaps that the following investments will be addressing. Investment Justification to include all Investments.

The MBHSR utilizes an all-hazards approach in meeting our mission; to build and sustain Region-wide enhanced capabilities in order to reduce the loss of life and property and protect the Metro Boston Homeland Security Region from all hazards, including natural disasters, acts of terrorism, and other manmade disasters, and to realize its vision: creating a Region that is capable of minimizing all hazards and threats, and ensuring a safe and secure Metro Boston Homeland Security Region. Homeland security and emergency management are inherently multi-disciplinary and multi-jurisdictional. Leadership is required to constantly analyze the juxtaposition of relatively static conditions such as demographics, critical infrastructure, and topography with highly dynamic conditions such as domestic and international threats, no-notice incidents, and severe weather conditions. When determining the dimensions of risk, officials must rely on an understanding of possible threats and hazards and what they require to prepare for, mitigate against, respond to, and recover from them. This task requires a multi-tiered planning process and institutional understanding to determine which capabilities and resources to maintain or improve. The MBHSR Strategy provides a framework to plan and prioritize homeland security efforts across the Region. The development of the Strategy is guided by DHS requirements as outlined in its 2005 State and Urban Area Homeland Security Strategy: Guidance on Aligning Strategies with the National Preparedness Goal (Guidance). The Guidance requires that each UASI use its strategy to outline the goals and objectives that reflect specific priorities. The MBHSR will continue to utilize UASI grant funding to address multiple Core Capabilities across all mission areas of the National Preparedness Goal. The region continues to focus on; Cybersecurity, Environmental Response/Health And Safety, Health And Social Services, Intelligence and Information Sharing, Interdiction and Disruption, Long-Term Vulnerability Reduction, Mass Care Services, Mass Search and Rescue Operations, On-Scene Security Protection, Operational Communications, Operational Coordination, Planning, Public Health and Healthcare and Emergency Medical Services, Risk Management for Protection Programs and Activities, Screening Search and Detection, Situational Assessment, and Threats and Hazards Identification among others.

II.F - Investment Description:

Since 2010, Massachusetts has experienced 11 disasters that have resulted in Presidential emergency declarations and/or disaster declarations. These incidents reflect the range of threats and hazards to which the state is vulnerable. For example, four of the 11 incidents were blizzards; three were tropical storms/hurricanes; a series of tornados on a single day in June, 2011; major flooding in 2010; a catastrophic water system failure in 2010 and the Boston Marathon terrorist attack in April, 2013. With help from the Homeland Security Grant Program, Massachusetts has built capabilities that have enabled us to prevent, ptrotect, respond to, mitigate against and recover from these and other events. Boston and Massachusetts were strong in the wake of the 2013 bombing and manhunt because we had been preparing for the previous decade. We are better coordinated across disciplines and across jurisdictional boundaries because of our statewide homeland security program that provides a framework for regular stakeholder meetings and promotes cross-discipline and cross jurisdictional coordination. As a home-rule state with 352 municipalities and no county level government or services, the regional councils and issue-specific working groups have provided the catalyst for these coordination gains. The THIRA and SPR process also helps stakeholders identify areas in need of on-going support or emerging issues where we need to build capabilities. This year, the Commonwealth hopes to see its four non-UASI homeland security planning regions coordinate their efforts to ensure that tech rescue teams across the state share equal capabilities. We anticipate continued support for interoperable communications, CBRNE, operational coordination, whole community engagement and mass care services. Massachusetts also plans to focus on newer priority areas as highlighted by scenarios in the 2015 THIRA, such as active shooter, countering violent extremism and cyber security. The explosive devices scenario in our 2015 THIRA depicts a multi-site attack not dissimilar to the attack in Paris. As we grapple with the nuanced issue of countering violent extremism, we hope to invest in projects related to counter-messaging or community resilience. Cyber security continues to be a newer but important area of focus. In 2015 the Executive Office of Public Safety and Security established a cyber working group and has begun to hone in on promising statewide program.

Project Description: The Department of State Police (MSP) is creating and adding a new operational division within the MSP - the Division of Homeland Security and Preparedness (DHSP). DHSP will be well-suited to coordinate homeland security planning and response protocols. It will also provide real-time situational awareness and a common operating picture to all levels of government tasked with ensuring public safety, utilizing a multi-disciplinary approach. Addressing the identified threats can be accomplished by allocating resources and responses based on the collection and analysis of data, thus providing local, state, and federal agencies with data that is actionable. The MSP is seeking funding to create within the DHSP the Real-time Watch Center (Watch Center) which will serve as a statewide 24/7 operations center that will bring together a wide variety of real-time information into a central location. This will greatly improve response and coordination capabilities for any significant incident in the Commonwealth. The DHSP Watch Center will address public and private infrastructure security by establishing liaisons within a Commonwealth Critical Infrastructure Security Team. The Watch Center will be located at the Massachusetts State Police General Headquarters (GHQ). The Commonwealth Fusion Center (CFC) facilitates statewide information sharing among local, state, and federal public safety agencies and private sector organizations. Such information sharing facilitates the collection, analysis, and dissemination of intelligence relevant to terrorism and public safety. The Fusion Center acts as a liaison to the Regional Homeland Security Councils and attends all meetings with the focus on critical infrastructure in each region. The CFC also produces the Statewide Threat and Vulnerability Assessment, an annual report detailing the Commonwealth's Critical Infrastructure sector, vulnerabilities, and any relevant threats. The Watch Center project will give the Fusion Center the analytical enhancement it needs to increase data collection and analysis to aid our public safety efforts across the entire state.Long-term costs associated with this project will be absorbed within the Department's Budget.
