This investment area focuses on securing the MBHSR community's safety and on improving various components of emergency response. In the 2018 National Preparedness Report it was identified that Operational Coordination was a key area of focus. "Lessons learned from recent disasters reflect the continued importance of strengthening coordination structures and processes to quickly act, streamline efforts, and enhance situational awareness." Investments in Regional Emergency Operation Center Upgrades and Emergency Management Software and Equipment Maintenance (specifically WebEOC) will help support and streamline efforts across the MBHSR, especially in the response and recovery mission areas, when it comes to incident command and resource management. In addition, the Emergency Management Software and Equipment Maintenance IJ addresses what was captured in the 2018 THIRA/SPR in the Equipment section of POETE for Logistics and Supply Chain Management. It was identified that this area needed to be built as well as sustained which indicates that shelter support equipment such as emergency generators, portable light towers, and VMS boards need to be maintained and replaced when they come to their end of use. The On-Scene Security, protection, and Law Enforcement core capability was identified in the 2018 THIRA/SPR to have gaps in both organization and equipment which will be addressed with the SWAT/SRT Equipment project where investments will be made in to the SWAT teams around the MBHSR so they can increase their capabilities and standardize across jurisdictions.

Additionally, new hardware, additional storage and licenses will be purchased for the ACISS virtual machine due to expanded functionality and increased usage by additional MSP employees to support enhanced information sharing. It will provide cyber training, intelligence analyst training, and training of CFC law enforcement liaisons, a CFC training conference, as well as a joint training conference with the New England High Intensity Drug Trafficking Area (NEHIDTA). This funding will allow us to sustain the gains we have made. In 2011, we did not have a dedicated privacy officer and only scored 66.7% for Enabling Capability 1 (EC1). We have been able to hire a privacy officer through grant funding and have now achieved 100% compliance with (EC1). To sustain these gains the CFC must continue to employ the contracted analysts, Privacy/Security Officer, Training Coordinator, Liaison Analyst, Watch NSI SAR Analysts and cyber analyst hired with grant funding. These positions increase intelligence sharing by facilitating the CFC's progress in the NSI as well as effectively increasing the CFC's analytic capabilities and the Commonwealth's ability to more effectively identify the threats related to the THIRA process.

Project Description: The Department of Fire Services (DFS) Hazardous Material Response teams and Massachusetts State Police bomb technicians enter into hazardous environments as part of their daily responsibilities. The personal protective equipment worn by both teams often impairs the ability of the individual to clearly see within this environment. Hazmat suits can "fog" up due to condensation making vision extremely difficult. Often technicians must spend unnecessary time in hazardous environments performing reconnaissance of the area of concern. Slip,trip and fall hazards and other potentially dangerous situations are commonplace. The Wireless Video Camera System with Remote Secure Access systems (10, one for each Tactical Operations Module (TOMS) and Squad vehicle in the hazmat division) will allow for district hazmat teams and the MA State Police bomb squad to monitor real-time down range operations from a remote location, detecting and identifying potentially hazardous materials or contaminants, afl while mainta ining a safe distance. With long-range, zoom and infrared capabilities, downrange technicians can be guided to avoid these situations and concentrate on specific targets. Safety officers can monitor downrange operations remotely to avoid unnecessary safety issues. In addition, these systems would allow other entities the ability to receive live audio and video feed. All potential viewers must be provided an encrypted passcode to enter into the system, limiting the possibility of unwanted or unauthorized viewing. Cameras can be carried by downrange personnel, secured to an extendable pole or mounted on a remote controlled tripod in the "hot zone". An available option allows the responder to "look" under doors and is attachable to the pole grip. Video can be recorded for post-incident review. Systems are ruggedized and are able to be decontaminated after use, when necessary. The system in use is called a MANET. This system is a group of mobile (or temporarily stationary) devices which need to provide the ability to stream voice, data, and video between arbitrary pairs of devices utilizing the others as relays to avoid the need for infrastructure, creating a mobile adhoc network (MANET). Currently, downrange monitoring is limited to radio transmission. These transmissions are difficult to hear due to the muffling effect of the personal protective equipment worn by responders in these environments. Conditions often have limited lighting when facility electrical systems are shut down for safety reasons. Critical information often needs to be repeated or is misinterpreted. The camera system allows for live streamed video to be reviewed by observers with unobstructed vision. Labels, devices, etc. can be clearly seen. Sampling targets can be easily identified and relayed back to team members to decrease time in the hot zone. Subject matter experts (industry experts, scientists, etc.) can view all that is occurring in the hot zone and provide invaluable advice on mitigation strategies.

Project Description: The MCCA is seeking to develop a comprehensive response plan to a cybersecurity attack at its venues. As a result of past, and current breaches in data confidentiality, integrity, and availability, the MCCA believes that it is vital to the safety and security of its employees, guests, and facilities to have clear and actionable cybersecurity incident response plan should such an event occur at their properties. The MCCA is requesting funds to conduct a table top exercise and a follow-up full-scale exercise at the Boston Convention & Exhibition Center (BCEC), in partnership with the Massachusett s of Emergency Management. The exercise will involve a Table Top Exercise and a simulated cybersecurity attack to assess the response of Law Enforcement and Emergency Response agencies from the City of Boston and the Commonwealth . In addition, it allows the MCCA to further refine and improve those partnerships in a cyber-simulated attack environment. The full-scale exercise will provide a "real world" cyber incident to allow MCCA officials and participat ing agencies the opportunity to practice and refine their existing cybersecurity incident response plans for public assembly venues such as the BCEC. Cybersecurity attacks are becoming more widespread, destructive, sophisticated and expensive which demonstrates the need for a collaborative response plan between city, state, and private sector entities in the event of a cyberattack. This exercise allows for the fostering of these relationships, as well as providing training to participants on the digital infrastructure of the largest public assembly venue in the Commonwealth. At the BCEC, our largest events attract up to 40,000 patrons at any one time inside the building and surrounding the outside of the property during parking and registration. Due to these large crowds and the impact they have on surrounding business and the city itself, it is imperative to have a comprehensive and robust Cybersecurity incident response plan ready in the event of a Cybersecurity attack.

Project Description: The rapidly expanding civilian drone market is being used by hobbyists and professionals alike as an excellent airborne photo, video and delivery platform. The government predicts the total U.S. fleet of small drones will reach 1.6 million this year. At the same time, however, growing concerns about criminal and terrorist use of the devices has created a heightened concern in the US Homeland Security sectors. There have been numerous, high profile criminal usage of drones overseas including: August 2018 attack on the Venezuelan President, July 2018 incident where a drone with inert grenades landed on the Mexican Secretary of Public Safety, 2017 incident where Cartel members were using UAS to smuggle drugs into a Georgia state prison and airport disruptions in December 2018 and January 2019 in the UK. The MSP UAS Section has been actively researching and testing available Counter-Drone technology measures since the November 2017 incident where a person was using a drone to drop anti-media leaflets over two NFL stadiums in California. Currently the laws prohibit State or Local entities from using RF jamming devices or use of any type of physical capture as a drone is considered an aircraft by the FAA. The only alternative available for use now is an electronic identification system for dro'nes. Having researched and tested numerous counter drone technologies the MSP partnered with Gillette Stadium to become the first agency in the US to employ DJI Aeroscope electronic identification technology. The DJI Aeroscope is a passive antenna system that intercepts the radio communications between the remote-control device and the drone. Its graphic user interface's encrypted website alerts to the presence of the drone, the drone location I altitude I direction of travel I serial # and type of drone. It can also give the coordinates for th drone remote control and the home point it took off from and/or will return to. The history of all flights it captures is saved to a flight history folder allowing for investigation if a delayed report of careless or suspicious drone activity is received. Currently, it only works with DJI drones - which encompasses over 80% of the drone market. It is anticipated this system will be able to detect multiple manufacturers once the unique identifier requirement for all drones is fully enacted as noted in the 2018 FAA Reauthorization Act. The MSP has (1) antenna and has been using this system since July 2018 with great success at venues such as Gillette Stadium & the Boston Marathon. It was this system that allowed for rapid identification of the pilot flying the drone over Fenway Park on 4/11/2019. Without this system there was very little chance of locating the operator. Our proposal is to purchase (8) additional Aeroscope antenna systems. They will be installed at strategic geographic locations on/at infrastructure that is owned or has cooperative agreements with the Commonwealth. Each antenna system needs 110V power, a T-Mobile service area OR hardwired internet connection and a high above ground mounting point in a secure area. Preliminary locations of installation likely to be: Cape Cod, Brockton, Wellesley, Lowell, Worcester, Leominster, Springfield and Boston areas - locations subject to change based on coverage range and in preparation for pre-planned events. Additional Aeroscope units will allow for greater coverage of critical infrastructure/key resources (CIKR) within the Commonwealth to protect venues including large open-air venues (Fenway, Gillette, Marathon, July 4th celebrations in Boston, prisons, power plants, water resources and other areas deemed critical by homeland security evaluations or fusion center intelligence). If the grant is approved, they will be positioned strategically throughout the state to maximize coverage of the above listed CIKR concerns and can be moved as needed to provide additional monitoring as needed.

Project Description: The MSP sUAS (small unmanned aerial systems aka Drone) section is a two-man unit tasked with providing aeria I support services for scenarios including: Tactical support for high risk scenarios that can greatly reduce the risks to first responders, search & rescue missions for missing and endangered persons, aerial mapping of crime and crash scenes (to provide quick clearance of roadways reducing risks to first responders, enable the timely movement of commerce and reduce the inconvenience to the motoring public) and to assist in missions when the manned aviation unit is unavailable due weather restrictions or other unforeseen circumstances. The MSP UAS section only has (1) drone capable of all-weather flight with FLIR and camera payload capable of supporting these requests. With this one drone the UAS unit has responded to requests for service all over the Commonwealth and has responded to critical incidents in Connecticut and New Hampshire for NESPAC mutual aid. MSP UAS section is looking to purchase additional drones to increase the personnel with access to a drone, reduce our response times and expand our capabilities. The sUAS's described below were selected due to their all-weather capabilities making them capable of flying in inclement weather, multiple mission capabilities and/or smaller size to assist in indoor or confined space operations. They can utilize multiple cameras, lights and/or communication devices to provide accurate and real time imagery during situations that manned aircraft is not available or is unsafe. They can be used for tactical situations and high-risk situations that would significantly reduce the risk of injury or death to first responders and civilians. These sUAS systems would enable the Commonwealth to distribute video feed on a secure system, giving public agencies and partners access to the sUAS capability. sUAS services will be available to all federal, state and local agencies. The sUAS can also be utilized at the early stages of an incident, providing real time imagery that can be gathered prior to establishing an Incident Command Post. With this technology agencies would be able to gather real time imagery that will enhance life and safety while providing the citizens of the Commonwealth with superior intelligence against acts of Violence and Terrorism. The sUAS has the capability to fly into zones that the current Air Wing helicopters are not able to, including but not limited to: Unknown hazmat situations, indoor barricaded suspect situations, armed suspect situations (Boston Marathon Bombings, suspect hiding in boat), inclement weather conditions and disaster situations where it is not safe for ground troops to enter. Our proposal is to purchase (2) all weather OJI Matrice 210 sUAS, (9) OJI Mavic 2 Enterprise dual sUAS, (9) OJI Spark sUAS and (9) Apple iPad Pro tablets (used to see flight data, camera feed and can broadcast feed with a Wi-Fi connection). This would allow for the (2) full time UAS personnel to have access to the latest all weather sUAS platforms strategically positioned in the north and south sections of the commonwealth for quicker response times to critical incidents as well as have access to smaller drones that would be used for mapping crime and crash scenes, used in tactical situations within confined spaces and provide cost effective means to safely and efficiently provide real time imagery to all first responders involved in the mission. We would also identify & train additional remote pilots within all MSP troops and issue them smaller Mavic drones to provide rapid deployment and further reduced response times.

Project Name: MSP-LPR Upgrade

Project Description: MSP proposes an upgraded/enhanced Automated License Plate Reader (ALPR) application, corresponding maintenance, database support services and customizations to enhance ALPR capabilities. The upgraded application will enable user access to enhanced queries which will enhance intelligence and information sharing capabilities. Nearly all terrorism cases that the MSP has been involved in have included a vehicle license plate component. Outages in the current application have caused mission critical reads to not be captured and stored in the database. Users have been unable to login to the application to perform queries or add hotplates during police operations. Query times have been delayed or not returned and hotlist hit notifications have been delayed or not sent. BOSS 3.6 is currently used to host MSP ALPR data and is not currently under a service or support contract from the software vendor. This project would purchase new software (BOSS 4.0) with maintenance to ensure that any software related issues are resolved in a timely manner and that any new software features are provided. Due to the size of the current database, database tuning and maintenance services would also be provided. This software and support will help reduce outages. The current application does not allow data sharing between others using the same software or disparate law enforcement agencies applications. In the event of a mission critical license plate needing to go into a hotlist, it would need to be entered into every application hosted throughout the law enforcement community. This slows response, increases errors and is a challenge for law enforcement during off hours. Reads are also not easily shared across existing applications due to version differences and software vendor incompatibility. BOSS 4.0 will provide hotlist data sharing between other BOSS 4.0 systems and enhance information sharing.

Project Name: MBTA-Operation FIND

Project Description: This grant award will fund the planning, design and execution of a functional intermodal drill to assess the capabilities of multiple first responder agencies to institute and support responsibilities associated with establishing an area command organization as part of an overall incident command structure. Two large cranes fall from a construction project overlooking the Boat Section of the Ted Williams Tunnel behind the Highway Operations Center. One collapsed crane blocks roadway traffic to and from the Ted Williams Tunnel to Logan Airport and causes damage to the Silver Line overhead electrical wiring and right of way transit operations. The second collapsed crane lands directly on the Rockland Trust Bank Pavilion tent during a concert causing several injuries to people both inside and outside of the venue. The drill is agnostic with respect to causation and designed to reinforce preparedness and response protocols to support a large-scale catastrophic event. The drill supports an ongoing security, preparedness and response posture for an all hazards type of event, including but not limited to a potential coordinated attack, inclement weather, human error or equipment failure at an industrial construction work site. The drill will simulate response to an industrial accident at a local industrial/construction site that has impacts on multi modal transportation operations and a private sector concert venue attended by the public. Response and recovery will require multi-jurisdictional notification, communication, and situational awareness. It will provide a forum for first responders to utilize new tools and technologies to support search and rescue operations, establish a unified and common operating picture, and review response and recovery protocols for a major incident that may have a basis in terror or other factors.
