**Welcome**

- Sarah Plowman, Boston OEM, opened the PSnet Executive Committee (PSNEC) meeting.

**Vendor-specific Updates**

- Karen Coye, FTG, reported on recent projects.
  - FTG successfully replaced UPS batteries in four sites.
  - FTG collaborated with Interisle to reinstall a DragonWave radio at the East Boston High School site. FTG will make a return visit tomorrow, February 15, to double check that all is working well.
  - FTG is continuing in their engineering review of the network. To that end, FTG and Interisle met on January 12, and another meeting is scheduled for Thursday, February 16.
  - Karen reminded the PSNEC that FTG would still appreciate taking a look at a PSnet (1-, 3-, and/or 5-year) equipment replacement plan, should one exist.
- Chuck Wade, Interisle, reported on recent projects.
  - Interisle has been working to transition infrastructure services off of an old server.
  - Much work has been done this past month to set up a system logging service for all PSnet systems and devices.
  - In collaboration with LAN-TEL, Interisle worked toward hardening CIMS infrastructure and firewall protection.
  - InterMapper had been experiencing some software issues; Interisle successfully worked with Help Systems (the vendor) to stabilize these problems.
  - Interisle continues to deal with a string of outages across the network, addressing problems as they arise.

- Eric Johnson, LAN-TEL, reported on recent projects.
  - LAN-TEL has been installing new CIMS cameras and working with Interisle for network support.
  - A router is going in at the Revere Hotel in downtown Boston to make the connection more robust.
  - LAN-TEL is working with the Chelsea Soldier's Home site upgrade project.

**Identify Needs and Next Steps**

- Everett Bridge Wave link from Whidden to Police Department
  - In response to a recent email from Interisle calling attention to an outage problem at the Whidden site in Everett, Sarah opened discussion among the PSNEC to explore next steps.
  - The condition of the site is less than ideal. Cables in disarray, lack of proper air conditioning, and other complexities led the discussion toward exploring finding a new long-term solution. Re-wiring the cabling was suggested, as was using fiber.
  - PSNEC members may want to write an abstract for FY17 funds to clean up the site or explore finding a different one, or perhaps investigate whether FY16 PSnet funds can be put to this task.
  - It was also suggested to connect with PSnet and/or UASI Communication Interoperability Subcommittee (CIS) members in Everett so that they might draft a proposal consisting of a long-term fix that is both cost-efficient and reliable. It may be possible to loop this conversation into a microwave backhaul project taking place in Everett and being implemented at the CIS level.
- Data storage servers
  - Chuck brought to the group's attention that there are data storage servers that should be updated due to reliability issues. There is a need for expanded capacity.
  - Scott Wilder, Brookline PD, requested that Chuck send an email with the specifics and the committee will look into it.

**Old/New Business**

- FY17 Abstract Process
  - Deirdre Habershaw, OEM, reminded the group of the FY17 Abstract Process. The abstract window is now open and runs until Monday, February 27, at 9:00am. In order to facilitate the abstract writing, Deirdre requested input from all vendors regarding equipment to purchase or needs to address in the next year or two.
