- Working to continue UPS upgrades region-wide.
- Identified five additional sites for security cameras at PSnet locations.
- Started the Everett Hospital HVAC project.
- Chuck Wade, Interisle, gave a summary of key projects since the last meeting:
 - Experienced good collaboration for the Marathon.
 - Continued planning to replace old microwave backbone links across the network.
 - Introducing better tools to monitor and capture information regarding security risks across the network.
 - Continuing to fix InterMapper glitches.
 - Providing specs and quotes to OEM for equipment purchases.
 - Working with Tellus on integrating and updating software.
 - Continuing to do work on Quincy PSnet sites.
 - No real problem resolution to report – haven't had many network problems.
- Skywave was absent.

UASI FY16 Budget Update

- FFY16 Balance
 - Sarah Plowman, OEM, reported that the purchasing is going well overall.
 - The group discussed Microsoft licensing needs for the PShet servers and determined that OEM will procure 2019 or 2016 licenses, whichever is available and at a better cost.
- A brief conversation took place regarding a Boston PSnet site replacement/swap.
 - The roofing project at the proposed site is wrapping up. This site is still a viable option.
 - Interisle is to send a list of equipment necessary for that site to John Surette to communicate up the chain with the State.
 - Interisle noted that they will need roughly 6 weeks advance notice to start getting the microwave licensing changes in place.

Old/New Business

- BoNet/PSnet conversation will take place soon regarding fiber and microwave traffic. The meeting will include stakeholders, regional IT staff, and vendors. The goal will be to a) hear what individual jurisdictions want to do, and b) determine what is feasible.
- Next Meeting proposed for second week of June, details TBD.
