

JPOC Meeting notes – May 8 2015
Boston EOC

- Meeting commences at 10:15am
- Update from Michelle Goldman (EOPSS)
 - Kurt Schwartz will remain in charge of MEMA but a new Undersecretary for Homeland Security will be named by the Governor at some point soon
 - Hans Olson has joined MEMA working on Cybersecurity and Anti-terrorism programs
- UASI FY15 grant award totals \$18 million
 - EOPSS currently takes 20%, Chief Doherty has put in request to reduce to 15%
 - UASI award will be \$14.4 million
 - \$720,000 M&A for OEM
 - \$13,680,000 for projects
 - \$30 million in abstracts received
 - \$21 million in abstract prioritized

- Goal 9 – Recovery
 - Rene recommends debris management plan be reduced to \$250k
- Goal 8 – Risk Management
 - Minimum funding for Digital Sandbox is \$90k per Rene
 - Chief Doherty asking what different in funding is (\$250k vs. \$90k)
 - On-site support + annual maintenance
- Goal 7 – Community Preparedness
 - Training and Exercise (T&E) Program to include Urban Shield
 - Lt. Gillan inquires as to status of next Urban Shield – Rene confirms next Urban Shield in 2016
 - Rene confirms EM Planning Cell reduced to \$800k
 - Rene confirms T&E reduced to \$900k, Chief Doherty confirms
 - Lt. Gillan explaining how much Jim Baker's (Cytel) consulting firm takes out of overall Urban Shield budget (\$325k)
 - HSEEP is complex process and even though documentation is already in hand departments don't have personnel to dedicate to HSEEP requirements
 - Lt. Gillan concerned his exercise did not get UASI grant funding
 - Chief O'Leary confirms funding for EM Preparedness Buddies over the Regional Mobile EOC
 - Dep. Nee suggests Psych. Trauma be reduced to \$50k
 - Doherty requests Regional Shelter Training but it can be done free through the Red Cross per Rene (additional costs covered under T&E per Rene)
- Goal 6 – Med Surge
 - Chief Doherty concerned no projects were reduced, some were increased
 - Chief Hooley confirms Hemorrhage Control can be reduced to \$150k
 - Chief Hooley confirms Training for ESF8 can be reduced to \$300k
 - Rene confirms LAMMP project can be reduced to \$50k (does not cover new vehicles, only weatherizing existing units)
 - LAMMPs only used in special events, not basic operational
 - Chief Hooley confirms Pharmaceuticals can be reduced to \$116k at a minimum
 - Chief Reardon concerned much of this is basic operational equipment

- Chief Doherty concerned this is not a regional project
 - Dep. Nee asks if we can provide items to private for profit EMS companies
 - Chief Doherty confirms fire departments can take possession of pharmaceuticals and distribute accordingly
 - Rene confirms the expansion of the Patient Tracking system for \$100k
 - Mike Kane and Chief Hooley confirm Psychological First Aid can be removed
- Goal 5 – CBRNE
 - Nee confirms elimination of remote opening tools kits, reduction of Xray equipment in half, keep mitigation suit, keep TCV, and remote robot reducing Boston EOC request to \$315k
 - BFD Commissioner willing to contribute funding to CBRNE Decon. Support Vehicle. Rene confirms reduction to \$100k
 - Boston PD Crime Scene Unit evidence collection in CBRNE environment (training with fire) reduced to \$50k per Dep. nee
 - Lt. Gillan withdraws EOD K9 Transport Vehicle project in favor of K9 Radiation Detectors. Nee confirms removal of vehicle and funding of detectors at \$40k. Project later eliminated by group.
 - Chief Butler confirms Bomb Squad Enhancements reduced to \$125k
 - Rene confirms funding for 3 Portable Decon. Units for cots (Mike Kane state 4 units will be procured)
 - Chief Doherty reduces HazMat Detection Equipment to \$300k (50% of this goes to Boston per Mike Kane)
 - Storage units/shelving not allowable per Rene (no AEL – can only be purchased as part of trailer procurement)
 - K9 Bomb Dog Transport Vehicles – Rene confirms if grant didn't fund dog we can't buy equipment
 - Light Medical USAR equipment to remain at \$125k per Chief Butler and Doherty
- Goal 4 – Interoperability
 - Rene asks how much tech support we need on radios?
 - Radio Tech. Support
 - Chief Reardon suggest to move to other vendor rather than Atlantic Associates for David Menzies (not possible – non-compete)
 - Brenda confirms \$200k for 45 weeks
 - Brenda suggests reducing PSnet in favor of Tech consultant
 - Rene confirms \$400k for tech consultant
 - Chief Reardon has no issue with Interisle buying used refurbished equipment
 - Chief Reardon confirms PSnet reduced to \$800K
 - Deputy Nee withdraws MSP helicopter downlink project
 - Chief Reardon confirms dispatch consoles must be fully funded for installation
 - Chief Reardon point out fact that at the local level jurisdictions will have to fund radios at some point
 - Only specialty regional units need more expensive dual band radios,
 - Chief Reardon asks if regional backhaul can be reduced. Chief Graney confirms backhaul was combined with the microwave gap analysis project. Projects can be lowered to \$300k combined.
 - National Tactical Channels project cut per Nee and Reardon
- Goal 3 – Info Sharing & Collaboration
 - Training/travel moved to T&E

- Analysts reduced to \$1.5 million per Dep. Nee
- Hardware/Software reduced to \$400k per Dep. Nee
- Social Media Analytics reduced to \$200k per Dep. Nee
- Regional Analytics reduced to \$100k per Chief Butler
- FATPOT reduced to \$100k per Scott Wilder
- Cyber Threat cut withdrawn per Dep. Nee

- Goal 2 – CIKR
 - CIMS
 - Chief Reardon explains the Region needs to update the data backhaul before upgrades on cameras can take place
 - Reardon suggests \$1million
 - Cyber Security reduced to \$300k per Rene
 - Rene asks how critical the Target Hardening project is
 - Boston PD requested \$200k
 - Revere radio site needs a fence
 - Funding reduced to \$150k
 - Shotspotter expansion reduced to \$100k per Andrew Murphy
 -
 - How important target hardening per Rene – need Revere radio site fence, 200k for Romanoski – reduced to 150k
 - Shotspotter expansion down to 100k
- Goal 1 – NIMS
 - Mike Kiely withdraws Somerville Prime Mover project as they will have access to Somerville Fire vehicle
 - Lt. Gillan withdraws maritime law enforcement equipment over objections from Chief Doherty
 - SWAT equipment
 - Dep. Nee withdraws armored response vehicles
 - Lt. Gillan confirms withdrawal robot for \$40k reducing request to \$160
 - Chief O’Leary confirms Brookline withdraws robot as well
 - Brookline eliminate tactical robot and accessories for \$150k
 - Training for Brookline and Somerville combined into T&E
 - Throw phone for North Metro SWAT cut per Chief Doherty
 - Accountability system can’t be cut per Rene (BFD) – Dep. Nee requests full funding
 - TEMS moved to training & exercise per Rene
 - Lt McCusker (Quincy) submitted the Crisis Negotiation equipment project (throw phones) –
 - Lt Gillan discusses regional crisis negotiation team startup
 - Project withdrawn per Chief Keenan and Lt. Gillan
- Vote at 12:15pm – All JPOCS present approve funding as allocated. Meeting adjourned at 12:17pm.

- **Welcome/Introductions**
 - Andrew commenced meeting at 1:05pm

- **UASI 13 updates**
 - Regional camera upgrade update from Lan-Tel
 - Expectation is monthly maintenance costs will decrease dramatically in typical months (outside of major events such as the Marathon or weather related incidents).
 - Current monthly drawdown \$50-\$60k, likely will reduce to \$25-\$30k once all upgrades complete.
 - Focusing on antiquated cameras and antennae as well as backend servers and switches. Interisle has been helpful in identifying problem networking devices
 - Increase network capacity will allow for improved resolution and the possibility for addition of video analytics software (Briefcam)
 - Once issue discussed is loss of data during network outage. Each camera has its own internal storage which takes over when connection to PSnet goes down. When connection is re-established the stored data is automatically transferred to network storage. This is not permanent, local camera storage is limited to a couple GB max. Discussion to automatically reduce video resolution when this happens so camera is capable of capturing more video at lower quality/frame rate.
 - Discussion on facial recognition. Most in attendance are not interested due to privacy considerations.
