This email is in response to your public records request to the City of Springfield for "The ACLU seeks records related to the relationship between Springfield Police Department and IBM related to the offering, acquisition of, and/or use of facial-recognition technology, including but not limited to products and services like Watson AI. Records requested: The ACLU requests all such records created on or after September 1, 2019, including but not limited to: 1. Communications between any representative of the Springfield Police Department and any representative of IBM pertaining to any facial-recognition product or service, including any material sent by IBM or any of its representatives; and 2. Internal communications between representatives or employees of the Springfield Police Department relating to any IBM facial-recognition product or service."

Due to the capacity of the City to search for, collect, segregate and examine any records during its normal business hours of operation, the City is requesting an extension of twelve [12] business days until Friday, March 12, 2020 to provide any records that may be responsive to this request.

Should you be aggrieved by this response, you may appeal to the Supervisor of Public Records in the Massachusetts Secretary of State's Office pursuant to 950 CMR 32.00 and M.G.L.c. 66, §10(b).
