Mr. Falcon-Morano,

I have called your office and left a voicemail message with you to clarify a question I have regarding the records request.

The Wellesley Police Department has not purchased any facial recognition equipment or software. There are many different members of the department that may have received sales emails from companies that sell facial recognition products.

Could you provide me with the names of the companies you would like us to include in the email search? A preliminary search for the terms "facial recognition" has resulted in nearly 3,000 potentially responsive emails.

It will take a significant amount of time to go through all of these potentially responsive emails individually to determine which emails simply contain law enforcement or technology related articles with the phrase "facial recognition", sales emails regarding training for "facial recognition" etc. or which emails were sent from companies that sell these types of products.

Any clarification you could provide that will assist us in responding to your request would be greatly appreciated.
