Good day all,
It was great seeing most of you at the workgroup meeting.

The reason for this email is that I need help.

Based on the FBI information I received, you are all submitting arrest photos to the FBI.
I am working on a business case to allow our state to submit those too, and I am looking for the following information:

- Do you have a state repository for arrest photos on top of the FBI system?
 - o If yes – are you planning to keep it? **Yes, the state AFIS system retains all biometrics received, photos, prints, palm prints and iris (iris archive only)**
 - o Why? **Why not? Our agencies like to see the photo when they look up the arrest record in our systems, future fusion matching?**
- Is the FBI system valuable for you?
 - o Why? **YES< we will use this system for facial recognition by using the FBI Universal Face workstation. We currently send to the FBI so our mug shots are included to assist others. We use the FBI transactions IRQ and CPR to get FBI 10 prints and mug shots when we do not have them in our system , these are usually needed for investigative functions or latent comparison (10 prints)**
- What functionality do you use from the FBI system? **ALL of it. 10 print, latent, future facial matching, dispo reporting.**
- Is it used in the local agencies too? **YES- primarily latent matching**
- Do you have success stories to share? **We get many latent hits, we use it daily .**
