In the meantime, I have received word from EOTSS after you provided the most recently amended list of search terms. The new total is 230,534 emails which amounts to approximately 180gb of data. Please let me know if you wish to further reduce the list of search terms or proceed with these numbers.

Even putting the issue of fees aside, I ran a time calculation based on previously accepted fee petitions which use a 3 minute per email timeframe for reviewing and redacting documents. The results are that 230,534 emails would take a full time employee dedicated exclusively to this task approximately 6 years worth of 8 hour work days to complete. This is just for reference purposes to give you a sense of the magnitude of a request this size.
