On 8/22/2015 at approximately 1942 hours Police were dispatched to the area of [REDACTED] for a report of shots fired. Upon arrival Car 242 (Ptm Zioli) observed several [REDACTED] gang members getting inside of a white infinity sedan which was parked in front of [REDACTED]. Police also observed an Asian male subject identified as [REDACTED] (DOB [REDACTED]) attempting to walk inside of the above mentioned residence. Police grabbed ahold of [REDACTED] and escorted him off of the steps and ordered him to place his hands on his head, while also giving loud verbal commands to the four occupants of the vehicle to place their hands on the ceiling of the vehicle. Police conducted a Terry Pat for Officer Safety to [REDACTED]. Police then removed and Terry frisked the occupants of the vehicle: [REDACTED] (DOB [REDACTED]), [REDACTED] (DOB [REDACTED]), [REDACTED] (DOB [REDACTED]), and [REDACTED] (DOB [REDACTED]). Police then performed a search (for weapons) of the vehicle and surrounding area. It should be noted Police were unable to locate any weapons at this time. Police checked all of the subjects via NCIC, which revealed them all to be "Negative" at this time.

Police canvassed the area at which time they located 15 shell casings on [REDACTED]. Police requested BCI to respond to the scene. Police also observed 3 bullet holes that struck the house on the corner of [REDACTED]. BCI Detective Newton photographed / collected the evidence. Police were advised (by neighbors whom wished to remain anonymous) that they observed a silver sedan fleeing in reverse on [REDACTED] towards [REDACTED] while the passenger was shooting a firearm towards [REDACTED]. The witness then stated that they observed a subject running towards the vehicle while shooting at it. It should be noted the above mentioned subjects were uncooperative with the investigation at this time and stated they did not have a complaint regarding the subjects whom shot at them. Car 220, Sgt Carroll was on scene. TOT DETECTIVES & BCI.

On 5/18/14 at approximately 0052 hrs., C343 Ptlm. Martin, along with C344 Ptlm. Chin and C342 Ptlm. Pineau, were dispatched to [REDACTED] for a report of shots fired into a house. Upon arrival, police spoke with the 1st floor resident of that address who reported that someone drove by and fired several shots into his apartment. Although nothing was seen, the occupants of the first floor reported hearing possibly 4 shots. Police located 5 shell casings on the street as well as one projectile. There was one observed bullet hole in the first floor exterior wall near the front bay window. Police were also directed into the living room where there were two observed entry holes in the front wall as well as two projectiles that had struck the rear interior wall and fallen to the floor.

Also in the house at the time of the incident was a [REDACTED] and a number of guests including [REDACTED] and [REDACTED]

Police also spoke with the occupant of the second floor, [REDACTED] who stated that she heard a vehicle drive down [REDACTED] fired several rounds outside the house and continue down [REDACTED] towards [REDACTED]. After a moment she heard several more shots at a distance.

Sgt. Yekelchik and Sgt. McGregor Responded to the scene. Detectives were on scene. BCI responded and the scene was processed.

Car 14 (Clem-Scali)

Officers responded to Salem ER on the report of a gunshot victim. The victim alleged that he was shot somewhere on [REDACTED]. Officer Clem canvassed the area prior to going to the hospital and located one .40 Caliber shell casing in front of [REDACTED] (Sgt Kasle), was notified and responded to the scene. Detective Hogan of the Identification Unit responded and photographed the scene and recovered the shell casing.

The victim, [REDACTED] was being treated for a non life threatening gunshot wound to his left hand. The round appeared to have entered his palm and exited through the back of his hand. [REDACTED] said that around 2300, he began walking on [REDACTED] with the intent of going to the store. At some point, two males approached him and one of them fired a shot at him. He refused to provide any info on the description of the males and said that he was going by a "street code". He also went on to say that he use to [REDACTED] but is now a family member. After he was shot, he said that he didn't remember anything else.

It should be noted that visible powder burn was observed on [REDACTED] palm indicating that he may have been shot at very close range. [REDACTED] girlfriend, [REDACTED] said that she heard a loud bang from outside and found Yoeun running back to their house. She then drove him up to Salem Hospital. Hor was also unable to provide any further suspect information.

Nothing further to report at this time.
