

1. I am assigned as the State Police prosecutor for the Newburyport District Court and I was advised by the probation department that the subject in the attached photo has been using another subjects name, date of birth and social security number when being arrested. The subject in the photo was arrested by the Salisbury Police Department on March 13, 2009 for drug distribution charges. At the time of his arrest he identified himself as [REDACTED] DOB: [REDACTED] SSN: [REDACTED] of [REDACTED]. The subject was transported to the Essex County Sheriff's Department prior to his arraignment, where he was photographed and fingerprinted under the name he provided to the Salisbury Police Department.

2. A probation violation warrant was issued for [REDACTED] on December 8, 2009 out of the Newburyport District Court. In January of 2017 the real [REDACTED] was arrested on the warrant, at which time it was determined that he was not the subject that had been arrested by the Salisbury Police Department in 2009. It was also determined that the real [REDACTED] has never been arrested and has no criminal record.

3. I am attempting to identify the subject who was arrested on March 13, 2009 so that he may be brought to court to answer to the warrant and any new charges as a result of the stolen identity, and to remove the charges from the real [REDACTED] record. The photograph I have attached was taken by the Essex Sheriff's Department on August 19, 2009.
