Hi Kade,

Thank you again for your e-mail. After further review, there are approximately 8,134 items associated with this request.

Due to the volume of documentation and resources required to support this request, a fee will be required. It is estimated that it will take multiple parties from the Cambridge Police Department approximately one hundred and twenty (120) hours to process your request of these relevant records.

The City of Cambridge will waive the fees associated with the first 50 pages of documentation and the first two hours of processing time. As a result, the estimated fee would be \$1,823.10 (\$15.45/lowest applicable hourly rate x 118 hours) plus the cost of \$404.20 to print and scan the responsive documentation (8,084 x \$.05). Therefore, the total fee estimate is \$2,227.30.

This amount is payable in advance of the City actually complying with your request. You may pay by check payable to the City of Cambridge sent to my attention.

This is an estimate. If the amount you pay turns out to be more than was necessary to comply with your request, you will be refunded the difference. If the estimate turns out to be too little, the City will comply with the request to the extent paid for and will submit a new estimate to you to complete the response.

Thanks for your patience on this request. The Cambridge Police Department does not have a purchase agreement nor do we use any facial recognition technology. As a result, a number of the records requested would not apply for our Department.
