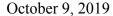

This is a request under the Public Records Law, G.L. c. 66, § 10, on behalf of the American Civil Liberties Union of Massachusetts ("ACLUM").

ACLUM seeks records pertaining to the sharing of video surveillance data, including but not limited to any interagency memorandums of understanding ("MOUs"), like the ones highlighted in page five of Exhibit A.

This request includes:
