Sir,

On Tuesday, July 13, 2021, I was advised by Legal Director Pat Lee that ICE Detainee [REDACTED] had tested positive for Covid- 19. Director Lee relayed to me that inmate [REDACTED] had been moved from unit H1 to the medical department -cell #116 at approximately 18:52 hours. He asked that a contact trace be conducted for possible exposure to other inmates and/or staff members.

I conducted video camera review on July 11, 2021 beginning at 1200 hours. At that time, [REDACTED] was housed in unit H1-cell #103. He was housed with inmate [REDACTED]. Both [REDACTED] and [REDACTED] also spent a significant amount of time together in the dayroom during their recreation period. On July 11, 2021, [REDACTED] was also in close contact with inmates [REDACTED] and [REDACTED]. These inmates were sitting right next to [REDACTED] in the back dayroom chairs for over an hour during their recreation time (1800-2200 hours).

On July 12, 2021, [REDACTED] had his recreation time from 0900-1100 and 1400-1600. During this time period he was seen in close contact with inmate [REDACTED].

On Sunday, August 15, 2021, while assigned to the IPS (Inner Perimeter Security) Department the following incident occurred. Deputy Counsel Isabel Eonas had requested camera review (CCTV) for contact tracing purposes regarding Officer [REDACTED]. Officer [REDACTED] tested positive for COVID-19 on the morning of August 15, 2021.

I conducted camera review on August 13, 2021 (1500-2300) in G Control. Due to the limited amount of camera in that area it was difficult to determine who Officer [REDACTED] was in close contact with. He was monitored on camera entering G Control at 1442 hours and then viewed leaving for his next shift at 2244 hours.

I also conducted camera review on August 13-14, 2021 (2300-0700) on G Floor. During this time period, Officer [REDACTED] did not have any close contact with any other staff members or inmates.

Deputy Counsel Eonas was contacted and updated with all camera review findings. All camera footage will be preserved and exported to the COVID-19 server and this report was generated due to Officer [REDACTED] positive COVID-19 result.
