Synopsis

The following is a summary of events that occurred on 18 October at approximately 1630 hours. The weather was partly cloudy and approximately 54 degrees.

While assigned to an evening shift, I, Trooper Brian R. Doak#3241, received a SERT call out to assist NHSP and the Ayer Police Department with attempting to locate evidence (f) investigatory which is believed to be related to an active New Hampshire State Police investigation.

I responded and conducted an aerial flight utilizing the Matrice 300 to help search the shore lines of a pond. I utilized IR and color images to assist SERT, NHSP, MSP Detectives and Ayer PD. I did not locate any evidence utilizing the Matrice 300 drone.

The flights were conducted in class G air space and remained below 220' AGL. A record of the flights are attached to this report.

Upon completing the flights, I assisted SERT with searching the shoreline, tree line and water. Negative findings, MSP Dive Team to be contacted for further assistance.
