1520 hours: Tpr Elliot CR1007K is first to arrive. Air Wing is requested and is deploying from Westover.

1540 hours: CR353 Sgt Sheehan on scene along with CAT Team and other assets and active search has started.

1630 hours: Capt. Heppleston CR2B on scene. Air 2 is launching and will arrive at approx. 1700 hrs.

Lt. O'Hara, MSP SERT, requested the Drone Unit to assist with the above mentioned search. Troopers Doak, Tiberi and Trombly responded. Troopers Doak and Tiberi utilized the Matrice 300 to search wooded areas, utilized the IR camera to search high probability areas for the missing female and assist MSP SERT with terrain navigation and low light operations, utilizing the drones IR and spot light. Trooper Trombly utilized the Mavic Dual Advanced to search tree lines utilizing the IR cameras, as well as identify potential locations of the missing female. During flight operations, MSP Drone Unit members were monitoring high wind warnings. After searching the assigned areas with the IR cameras, negative results. All assets were later cleared for the evening.

Operations were conducted in class G airspace. A copy of the flights are attached to this report. No photos or video were taken or stored.
