NARRATIVE

About 12:20 pm on Monday 01/03/21 Officers O'Connor and Panzavecchia in the C111D conducted a traffic stop at 844 Blue Hill Ave Dorchester.

It should be noted that Officers were responding to the area of Talbot Ave and Washington Street for a 3 round shot spotter activation (I222000497).

Officers while passing the intersection of Talbot Ave and Southern Ave, observed a blue 2016 Hyundai Sonata bearing RI registration with excessive window tint (MGL 90:9D) and no front registration plate (MGL 90:6). Officers observed the vehicle take a right turn from Southern Ave on to Talbot Ave toward Blue Hill Ave. Officers conducted a CJIS query of the registration revealing it to be "EXPIRED" (MGL 90:9). Officers proceeded to take a U-turn, in order to conduct a traffic stop on the vehicle.

Officers eventually got behind the vehicle in order to conduct a traffic stop for the violation at 844 Blue Hill Ave. Upon approaching the vehicle, Officers could not see inside the vehicle due to the excessive window tint (15%). Officers requested the operator roll down all of the windows. The vehicle was operated by and the passenger was provided Officers with a photo of a RI driver's license, and stated she did not have a copy of the registration. Officers informed the registration to her vehicle was expired, and conducted an exit order to both occupants. Officers frisked both occupants yielding negative results. Officers informed that the vehicle would be towed due to the expired registration. Officers conducted an inventory search of the vehicle.

Officers issued MA Uniform Citation for the violations:

MGL 90:9 Operating a motor vehicle with expired registration

MGL 90:6 number plate failed to display (front plate)

MGL 90:9D excessive window tint.
